Dear Sir,

I do hereby lodge written complaint empowered by the Electricity Act 2003 read with Amendment Act 2007 to the effect that **Sk Jamiruddin, S/O-Sk Jaynal**, a permanent resident of **Vill:Nimdanga, P.S -Neturia, Dist- Purulia** has committed theft of Electricity u/s 135 of the Electricity Act 2003 read with Amendment Act 2007 as stated hereunder.

On **18.03.2024** at about **02:20PM** I, Dhritiman Sardar S/O- Rupal Sardar, aged about 25 years, AE & SM Saltore CCC, along with Sri Souvik Mudi, J.E. (Gr-II) and Goutam Kumar Pandey, HGTSH both attached to Saltore CCC and others had been to the village: Nimdanga for routine inspection purpose. During inspection it was found that **Sk Jamiruddin** was consuming electricity dishonestly and unauthorisedly in his domestic premises by the way of direct hooking from the nearby LTOH line of WBSEDCL which resulted causing loss of revenue of WBSEDCL to the tune of load **0.52KVA**.

As theft of electricity was detected during inspection the illegal hooking line was disconnected & removed from the nearby electrical source and one no of two core stranded copper wire of faded white colour assorted size with hooking device has been seized under memo of seizure list in the presence of witnesses and their signature is also duly obtained in the seizure list but the accused person denied by putting his signature in the Seizure List, Inspection Report. The above seized materials duly packed and labeled at the inspection site and signature of the WBSEDCL representatives taken but the accused person refrain to sign the same. After completion of inspection, the inspection team left the aforesaid premises at about **02:40PM**.

Thus the accused **Sk Jamiruddin, S/O-Sk Jaynal, Vill: Nimdanga, P.S -Neturia, Dist- Purulia** have committed an offence **u/s 135(1)(a)** of the Electricity Act 2003 read with Amendment Act 2007.

You are requested to take cognizance of this complain treating it as FIR.
