Sir,

In producing herewith arrested one accused person namely Bhuttu Osta (35 Yrs) S/o Lt- Musuruddin Osta of Vill- Bamunbaid, PS Para, Dist- Purulia under arrest with one iron made improvised country made one shutter fire arms loaded with one round .303 Bore live ammunition and another one round from his right pocket under proper seizure list.

I would like to inform you that today at 20:40 hrs. O/C Para PS received telephonic information that one person loitering Kashiberiya More under Para PS in a suspicious manner believed to have a fire arms in his possession. Accordingly the matter has been diarized vide Para PS GDE No- 180 Dtd- 04.03.2024 and as per order of O/C Para PS myself along with, C/1407 Susanta Goswami , C/351 Kanilal Bauri and C/1108 Dhananjoy Hazra all of Para PS left the PS with Govt. vehicle to work out the information vide GDE No- 181 Dtd- 04.03.2024 vide C.C. No- 703/2024 Dtd- 04.03.2024. Myself along with force reached at Rukni more with accompanied ASI Prabhash Ch. Bauri & his forces.

Myself along with officers and force reached nearby Kashiberiya more under Para PS with a distance and keep the vehicle and move towards the spot by feet. When we reached to the spot at about 21:15 hrs. we found one person wearing with sky colour shirt was moving suspiciously and seeing us he was trying to escape from the place. But we managed to apprehend him and asked him in which purpose he was moving here and there at Kashiberiya More, he failed to give any satisfactory reply about his presence. On being asked he disclosed his identity as noted above but he failed to produce any valid identity in favour of him. In course of searching his body along with his wearing apparels one iron made improvised country made one shutter fire arms loaded with one round .303 Bore live ammunition and another one round from his right pocket recovered from his exclusive possession. On being asked he failed to produce any valid documents in respect of said fire arms and ammunitions.

Accordingly I seized the said recovered iron made improvised country made one shutter fire arms loaded with one round .303 Bore live ammunition and one round from his right pocket under proper seizure list duly signed by him, Police witnesses and one local witness. It is to be noted that during seizure no public witness could be made available as it was night and I also arrested him after maintaining all formalities regarding his arrest.

Therefore, I pray that a specific case may kindly be started against the aforesaid arrestee under proper section of law.
