Sub: To lodge FIR against Sk. Insan Ansari S/o Lt. Surmali Ansari of Vill - Bahara Fatepur, PS - Para, Dist - Purulia, defecto complainant of Para PS Case No 61/2017 Dtd 28.06.2017 U/S 465/467/471/468/420 IPC and GR No 465/17.

Sir,

The nub of the fact in a nutshell is that on 28/06/17 at 16.05 hrs O/C Para PS received a written complaint from one Sk. Insan Ansari S/o Lt. Surmali Ansari of village Bahara Fatepur, PS- Para, Dist- Purulia that since few years his younger brother Mukshed Ansari is working at PWD Dept. now posted at Raghunathpur in Group - D post in the name of Sk. Insan Ansari. Mukshed Ansari forged some documents i.e voter card, AADHAR card etc. and use these as genuine. Thus he cheated the complainant as well as the department. Over this started Para PS Case No 61/2017 Dtd 28.06.2017 U/S 465/467/471/468/420 IPC and as per endorsement, SI Sibsankar Pal then SI Tapan Kr. Majumdar and as per re-endorsement of O/C Para PS SI Uttam Kr. Mandal took up its investigation.

During investigation of Para PS Case No 61/2017 Dtd 28.06.2017 U/S 465/467/471/468/420 IPC the prima facie charge U/S 465/467/471/468/420 IPC was not established on this case and also revealed that the defecto complainant Sk. Insan Ansari S/o Lt. Surmali Ansari of Vill- Bahara Fatepur, PS - Para, Dist - Purulia registered the case in spite of knowing the truth that his brother did not forged his documents. From the documentary evidences as well as statement of witnesses it was made clear that alleged person Muksed Ansary @ Sk. Insan Ansary S/o Lt. Surmali Ansari of Vill- Bahara Fatepur, PS - Para, Dist- Purulia did nothing illegal.

After collecting sufficient evidences IO SI Uttam Kr. Mandal submitted final Report on this case vide Para PS FRF No - 61/2020 dated: 30/07/2020 in this case with a prayer for submitting Prosecution report u/s 211 IPC against the complainant Sk. Insan Ansari S/o Lt- Surmali Ansari of village- Bahara Fatepur, PS- Para, Dist- Purulia.

Today i.e. on 18.03.2024 received Order sheet dated 01.03.2024 of Ld. ACIM, Raghunathpur Court, Dist-Purulia to the effect that Ld. Court is accepted the FRF of this case and also dropped the case and directed to OC, Para PS to draw FIR against the defecto complainant Sk. Insan Ansari S/o Lt- Surmali Ansari of village- Bahara Fatepur, PS- Para, Dist- Purulia.

Hence, I do hereby lodge this complaint to start a specific case against Sk. Insan Ansari S/o Lt- Surmali Ansari of village Bahara Fatepur, PS- Para, Dist- Purulia u/s 211/182 IPC.
