

1. That the complainant have started making bricks in a brick field that my own place for the sake of business at Tubukgarh plot no:-03 under mouza:- Rameswardih. I pay royalty regularity.
2. That on 13-02-2023 at about 10 A.M. the said three acced. acced. persons having come to the complainant demanded Rs:- 20,000/- (Rupees Twenty thousand )P.M.
3. That on the complainant denial, the above acced. persons assaulted by slapping, fist and blow
4. That the above acced. persons forcibly snatched 6500/- (Rupees Six thousand and five hundred )from existing money of the complainant.
5. That the complainant had made himself separated from the acced. persons.
6. That as a result in absence of the complainant, the above acced persons smashed the raw bricks that caused a huge loss to the complainant's business. Thereafter when the complainant protested their ill-activities, the above acced. persons loudly threatened by killing ultimately I was compelled to leave the place of occurrence.
