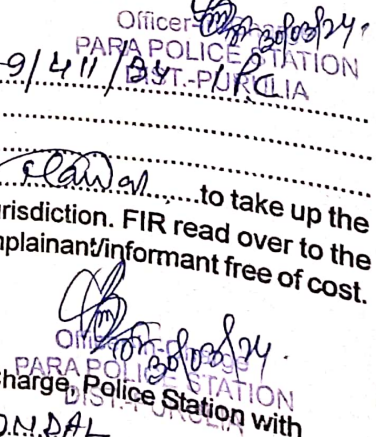

Sir,

In producing herewith the 04(Four) arrested accused persons namely 1.Ashamul Ansary @Chand S/o Ushman Ansary of Vill-Metal Sahar, PS-Adra, Dist-Purulia 2. Rajesh Rajwar S/O-Shyamapada Rajwar of Vill-Kashipur Rajwarpara PS- Kashipur, Dist-Purulia 3.Kiyananda Dey S/O-Bhagawan Dey of Vill-Kashipur Poddarpara,PS- Kashipur, Dist-Purulia 4.Samsar Khan @Nanka S/O Rajjak Khan of Vill-Kashipur Masjidpara PS- Kashipur, Dist-Purulia under arrest along with seized articles (i) One Red Colour Mahendra Jito Tempo bearing Reg No.-WB 81 2102 (ii) Various Parts of Old Disel Water Pump manufactured by Kirloskar Company bearing No-12DF10 84145 (Handel, Side Plate, Fan Blade, Head, Block, Pipe, Silencer. Fire Plate, Pump).

I, SI Suchaish Mondal In-Charge Anara OP under Para PS, Dist-Purulia beg to submit that on 29.03.2024 I along with 1. ASI Sisir Kr Mahato and 2. C/28 Uttam Mondal 3.NVF 841 Bibek Addy of Anara OP under Para P.S were performing special mobile duty vide Anara OP under Para PS CC No-569 Date-29.03.2024. During my mobile duty at about 04.35 hrs. on 30.03.2024 myself along with force reached near Ranipur Railway Subway under Para PS and found that One Red Colour Mahendra Jito Tempo bearing Reg No.-WB 81 2102 was coming from Kashipur side. On seeing the Police party at Ranipur Railway Subway, the said tempo was trying to flee away. But after a hot chase, we could able to detain the said tempo having No- WB 81 2102 loaded with Various Parts of Old Disel Water Pump manufactured by Kirloskar Company bearing No-12DF10 84145 (Handel, Side Plate, Fan Blade, Head, Block, Pipe, Silencer. Fire Plate, Pump). We also detained the driver namely Rajesh Rajwar S/O-Shyamapada Rajwar of Vill-Kashipur Rajwarpara PS- Kashipur, Dist-Purulia and other 03(three) passengers namely 1. Ashamul Ansary @Chand S/o Ushman Ansary of Vill-Metal Sahar, PS-Adra, Dist-Purulia 2. Kiyananda Dey S/O-Bhagawan Dey of Vill-Kashipur Poddarpara,PS- Kashipur, Dist-Purulia 3. Samsar Khan @Nanka S/O Rajjak Khan of Vill-Kashipur Masjidpara PS- Kashipur, Dist-Purulia. I asked them to produce valid documents in respect of said vehicle and carrying articles but they informed that the documents in respect of said vehicle and carrying articles were kept at the home of Ashamul Ansary @Chand S/o Ushman Ansary of Vill-Metal Sahar, PS-Adra, Dist-Purulia. The suspected persons and the tempo loaded with Various Parts of Old Disel Water Pump manufactured by Kirloskar Company bearing No-12DF10 84145 have been detained at Anara OP vide Anara OP G.D.E. No-495 Dtd- 30.03.2024. Nobody came to Anara OP/Para PS to produce any documents regarding the vehicle loaded with Various Parts of Old Disel Water Pump till 14.00 hrs. Finding no other alternatives I further interrogated them thoroughly. During interrogation, they admitted that they have been stolen the articles from Kashipur area and they were dealing with stolen articles. Hence, I seized the Red Colour Mahendra Jito Tempo bearing Reg No.-WB 81 2102 loaded with Various Parts of Old Disel Water Pump manufactured by Kirloskar Company bearing No-12DF10 84145 (Handel, Side Plate, Fan Blade, Head, Block, Pipe, Silencer. Fire Plate, Pump) in between 14.15 hrs to 14.45 hrs under proper seizure list maintaining all legal formalities and I also arrested 1.Ashamul Ansary @Chand S/o Ushman Ansary of Vill-Metal Sahar, PS-Adra, Dist-Purulia 2. Rajesh Rajwar S/O-Shyamapada Rajwar of Vill-Kashipur Rajwarpara PS- Kashipur, Dist-Purulia 3.Kiyananda Dey S/O-Bhagawan Dey of Vill-Kashipur Poddarpara,PS- Kashipur, Dist-Purulia 4.Samsar Khan @Nanka S/O Rajjak Khan of Vill-Kashipur Masjidpara PS- Kashipur, Dist-Purulia after maintaining all legal formalities regarding his arrest. This refers to Anara OP under Para PS G.D.E. No- 505 Dtd- 30.03.2024. I brought the said tempo having No- WB 81 2102 loaded with Various Parts of Old Disel Water Pump to Para P.S. compound as such there is every reason to believe that the arrested accused with ill motive are dealing with stolen articles without any valid document. So they are liable for offence punishable under the purview of law.
