Sub: Complaint for starting a specific case.

In producing herewith one arrested accd namely Mihir Hembram (22) S/O Sarada Hembram of vill- Lankagora, P.O-Jitujuri, P.S_Manbazar, Dist- Purulia driver of Tractor bearing Regd No- WB55B-0800 along with one trolley without registration number, loaded with sand approx 100 Cft. under proper seizure list. I beg to submit that today (07/03/2024) I, ASI Chittaranjan Mukkhopadhyay along with HG/1765 Falguni Ray & Special HG/1846 Panchanan Mahato all of Puncha PS were performing anticrime day mobile duty at PS area vide Puncha PS CC No - 702 /24 Dt-07/03/24 vide GDE No-299 dtd.07.03.24 at Ps area and at about 18:45 hrs, I received credible source information that one Tractor fitted with trolley is coming to Puncha side through kenda Napara pitch road loaded with sand illegally. Accordingly I intimated the matter to O/C Puncha PS over phone and as per his direction and under supervision of SDPO Manbazar we reached to the spot to work out the information. When we reached the spot that is kaira bridge under Puncha P.S at about 19.05 hrs and found the information is true and found that one truckter bearing Regd No WB55B-0800 loaded with trolley with illegal sand is coming to Puncha side through kenda Napara pitch road loaded with sand illegally, but on seeing the police party the driver of above noted vehicle (Tractor) suddenly stopped approx 30/50 meter away from us, got down from the vehicle and started running. We chased and apprehended him finally. Then we searched the vehicle(tractor) and found that the vehicle (Tractor) having registration No-WB55B-0800, along with trolley without registration number loaded with sand 100cft(approx).On interrogation the driver of the said tractor disclosed his identity as Mihir Hembram (22) S/O Sarada Hembram of vill- Lankagora, P.O-Jitujuri, P.S_Manbazar, Dist- Purulia. On demand he failed to produce any valid documents in respect of above noted Tractor along with trolley loaded with sand approx 100 cft. .

So, there is reason to believe that the driver and registered owner of this vehicle (tractor) and other have collected the said sand from Kaira sand Ghat or other place of Kangsabati river either by theft or by any fraudulent means and after hatching a criminal conspiracy, they were trying to dispose off the same at anywhere in a clandestine manner knowing it to be stolen as per their regular practice.

Accordingly I seized the said Tractor bearing Registration No WB55B-0800 along with trolley without registration number loaded with sand approx 100 cft under proper seizure list from accused driver of the tractor and duly signed by witness at kaira bridge under Puncha P.S jurisdiction and also arrested accused driver as noted above in c/w this case . So the driver and registered owner of this vehicle (Tractor) and others have committed offence u/s-379/411/414/120B IPC & 21(1)(4) Mines and Minerals (Development and Regulations) act, 1957.

Under the above fact and circumstances a specific case may kindly be started against the driver and the registered owner of the vehicle (Tractor) bearing Reg. No.- WB55B-0800 along trolley without registration & others , under proper section of law and arrange for its investigation.
