Puncha, District - Purulia, and threatening to kill me and my daughter Shiuli Rakshit. It is stated that since a long time, a dispute regarding a land has been ongoing between my husband and his sisters, namely Jaba Dutta, Kajol Dutta and Jyotsna Sen, and they have recently come back to their paternal house in Puncha. On 08.03.2024 at around 5PM, all three of them attacked me all of a sudden with bricks and hit my head multiple times, causing it to bleed. Hearing my shouts, my daughter Shiuli Rakshit came to my rescue but the three women attacked her with bricks as well. After hearing both of our shouts of pain, some people nearby came over and due to which, the three accused persons ran away but threatened to kill us before running away. The two of us sought treatment for our injuries at the nearby Puncha Block Primary Health Centre immediately. It is stated that we are living under the constant threat and mental pressure being created by Jaba Dutta, Kajol Dutta and Jyotsna Sen, who have been harassing us since a long time, and have now attacked me and my daughter in a violent way. They have even threatened to kill us. Kindly treat this letter as FIR.

## Respected Sir,

This is to bring to your kind notice that I, Rekha Rakshit, wife of Pradip Rakshit, resident of Village – Puncha, P.O. and P.S. Puncha, District – Purulia, was attacked by a) Jaba Dutta, wife of Sanath Dutta, b) Kajol Dutta, wife of Chittaranjan Dutta and c) Jyotsna Sen, wife of Nandeshwar Sen on 08.03.2024 at around 5PM.

It is stated that since a long time, a dispute regarding a land has been ongoing between my husband and his sisters, namely Jaba Dutta, Kajol Dutta and Jyotsna ßen, and they have recently come back to their paternal house in Puncha. On OS 03.2024 at around 5PM, while I was on my way back home, I was violently attacked with bricks by the accused persons. All three of the accused persons

attacked me all of a sudden with bricks and hit my head multiple times, causing it to bleed. Hearing my shouts, my daughter Shiuli Rakshit came to my rescue but the three women attacked her with bricks as well. After hearing both of our shouts of pain, some people nearby came over and due to which, the three accused persons ran away but threatened to kill us before running away. The two of us sought treatment for our injuries at the nearby Puncha Block Primary Health Centre immediately, and copies of our medical records are attached herewith. It is stated that we are living under the constant threat and mental pressure being created by Jaba Dutta, Kajol Dutta and Jyotsna Sen, who have been harassing us since a long time, and have now attacked me and my daughter in a violent way. They have even threatened to kill us.

I would like to make an appeal to you to treat this letter as FIR and look into this matter immediately so that appropriate steps are taken to ensure that we receive proper justice and are protected from the acts of the accused persons. We are living under the constant threat and mental pressure being created by Jaba Dutta, Kajol Dutta and Jyotsna Sen, who have been harassing us since a long time, and have now attacked me and my daughter in a violent way, and we are living under constant threat that we may be killed any day by the accused persons.
