Sub: Lodging of F.I.R of theft of Electricity against Gulnaz Khatoon, D/o Nishar Qureshi at her Domestic premises at Kasai Danga, P.S.- Purulia(T) and thereby committed an offence punishable U/S 135(1)(b) & (1)(d) of Electricity Act 2003 amended in 2007.

Dear Sir,

This is to inform you that, I Sri Subhajit Pratihar(34), S/O – Ambujaksha Pratihar, D.E. & Station Manager of Purulia CCC of WBSEDCL received an information to the effect that Gulnaz Khatoon, D/o Lt. Nishar Qureshi residing at Kasai Danga was committing theft of Electricity at her Domestic premises by bypassing the proper registration of units by tampering the Energy meter.

Acting on this information this day 14.03.2024, I alongwith Sri Partha Chakraborty, D.E.(S & LP) of Purulia Region Office, Sri Promod Ranjan Barman, S.O. of Purulia Region S & LP Unit, Sri Anurag Pandey, Office Executive of Purulia CCC and Sri Sanjoy Kumar Mahato, Sr TSH of Purulia CCC had been to the house of Gulnaz Khatoon at the above mentioned address. She was present at her house. We contacted her and disclosed our identity to her. On being asked she allowed us to inspect the Energy meter of WBSEDCL installed at her domestic premises against the name of the consumer namely Gulnaz Khatoon.

Also search for local people as witnesses during our inspection of the Energy meter of the said premises but none came forward though some local people gathered there. The premises was a two storied building. The meter is installed at the entrance of that premises. Immediately, a notice was prepared duly signed by the consumer served upon her and held inspection.

During inspection, it was detected that, Gulnaz Khatoon had tampered the energy meter installed at Domestic premises bearing meter No: GE0210149 in the name of Gulnaz Khatoon at the said premises to bypass the proper registration of units by tampering the meter circuit of the meter and seals of the said meter to commit theft of Electricity. Inspection also revealed that Gulnaz Khatoon was the actual user of the above mentioned service connection.

Immediately, on my direction Sri Sanjoy Mahato, Sr. TSH of Purulia CCC disconnected the above mentioned service connection and removed the Energy meter bearing SI no: GE0210149 after securing the installation place of the said meter from any imminent danger in future. Gulnaz Khatoon was shown the tampered meter but being asked she could not render any satisfactory explanation. She was informed about the offence committed by her and its penal provision.

P.T.O.

Sri Partha Chakraborty, D.E.(E) of Purulia Region Office prepared inspection report in her presence and witnesses at the spot and load assessed as 1.15KW. The details of inspection has been mentioned in the inspection sheet attached herewith.

From the evidence so far collected from the inspection of the energy meter of Gulnaz Khatoon, it is well established that Gulnaz Khatoon was consuming Electricity illegally in her Domestic residence and for this activity of theft the WBSSEDCL has incurred huge loss of revenue.

Sri Partha Chakraborty, D.E.(E) of Purulia Region Office prepared Seizure list in respect of the said premises and meter in presence of the consumer and witnesses at the spot.

The inspection was held between 12:55PM to 01:25PM today after observing all legal formalities.

It is well evident that accused Gulnaz Khatoon, D/o Lt. Nishar Qureshi residing at Kasai Danga has committed offence punishable U/S 135(1)(b) & (1)(d) of Electricity Act 2003 amended in 2007.

You are requested to take cognizance of this complain & treat it as FIR
