In producing herewith two arrested accused persons namely 1) Chaturbed Roy (34 yrs) S/O Anjun Kumar Roy of Hirbandh , PO+PS - Hirbandh , Dist-Bankura and 2) Kanchan Chatterjee (34 yrs) S/O-Hiralal Chatterjee of Vill - Kundruka, PO - Moshiara, PS - Hirbandh , Dist-Bankura and depicting the following facts to the effect that, I, ASI Abdul Hamid Ansary posted under Purulia Town PS was detailed to perform 2<sup>nd</sup> Special Mobile duty along with force vide Purulia (T) PS GDE No-1039 Dtd. 17.03.24 & CC No -685 Today i.e 17.03.24 at about 19:45hrs I got an information from the table officers that some persons are creating nuisance with the O/C Traffic Purulia in front of Big Bazar at Deshbandhu Road near Raghabpur more under Purulia Town P.S. In response to the information I rushed to the spot and found that the noted two persons were using abusive languages to the Traffic police personnel over the issue forceful obstruction of traffic. It was revealed that the said two persons are in drunken condition and in furious mood. They were causing nuisance to the general public also. When we tried to stop them and told them to leave the place they became furious and attacked us with fist and blows and kicks. One accused who later disclosed his identity as Chaturbed Roy was very aggressive in nature and attacked me forcefully and hit on my chest. The accused persons scuffled with us, used criminal force to on duty police in uniform and tried to deter us from discharging of lawful duty. Found no other alternative I seek help of other police personals from Police station and immediately ASI Bacchu Ghosh and other available police force of Purulia Town PS reached at the spot and after a vigorous effort we could able to arrest the said two accused persons. Even on the police vehicle also the accused Chaturbed Roy tried to assault police by throwing his hands randomly. After that we brought the said two accused persons at Deban Mahato Sadar Hospital for their medical examination and after that they were brought to PS.

Therefore I pray you to start a specific case under appropriate section of law for assaulting and using of criminal force to on duty police officer and voluntarily causing hurt to a me during discharge of my duty with the intention to deter me and obstruct me from discharging of my duty as such public servant.
