Sub: Prayer for lodging FIR.

Sir,

In producing herewith the seized vehicle (Tractor) having registration No- WB 55A 7917 attached with Trolley, loaded with sand approx 100 cft along with Seizure list.

The nub of the fact in a nutshell is that today (03.03.2024) evening while I, Navin Kumar Singh along with force (i) C/- 994 Srikanta Kumbhakar (ii) C/- 531 Shibsankar Mahanty & (iii) HG- 1576 Shaktipada Mahato all of Purulia (M) PS left the PS for performing evening night mobile duty vide Purulia (M) PS GDE No- 148 Dtd. 03.03.2024 in PS area. During my mobile at about 19.25 hrs, I received information about an illegal transportation of sand from Bhul Ghat under Purulia (M) PS. Accordingly, I informed the matter to you and as per your kind direction myself along with force left to work out the information. At around 19.55 hrs while we reached near Raibaghini Tample of Vill- Lagda we found one Tractor coming from Lagda village side. Seeing the Police party the tractor tried to flee away. After a hot chase the Police vehicle over taken the Tractor and tried to stop the Tractor in a safe distance, but the driver of the tractor intentionally hitting the Police vehicle having Registration No- WB 56C 5423 from the back side. After hitting the Police vehicle by the driver of the Tractor managed to flee away leaving the Tractor on Road.

Accordingly, I along with the force intercepted the vehicle (Tractor) without any driver or any other person. I found that the vehicle as well as goods was identical as I received prior information. I moved through the surrounding area to trace the said driver or owner of said detained tractor, but nobody was found to stand its ownership. During primary enquiry it was found that the owner and driver of the said vehicle (Tractor) loaded the said sand by illegal means to sell the same to make their own profit by dishonestly and they had been running a clandestine business. It is reasoned to believe that the driver in cahoots with the owner of the vehicle and others procured the said sand from the Kansai River under Purulia (M) PS side by fraudulent means or theft by any means to transport the same to run a clandestine business.

Accordingly, finding no other alternative way I seized the vehicle (Tractor) having registration No- WB 55A 7917 attached with Trolley, loaded with sand approx 100 cft under proper seizure list. The seizure was made in between 20.15 & 20.35 hrs in presence of the available witnesses duly signed by them. Thereafter, I brought the seized vehicle (Tractor) having registration No- WB 55A 7917 attached with Trolley, loaded with sand approx 100 cft to Purulia (M) PS compound for safe custody.

Under the above facts and circumstances, I therefore, pray before you that kindly take lawful action against the owner and driver of the seized vehicle (Tractor) having registration No- WB 55A 7917 attached with Trolley, loaded with sand under the proper section of Law.
