In the matter of the humble petition on behalf of the accused person.

#### The complainant begs to state as follows -

- That the I would like to inform you that, I Jayant Kumar Gupta Son of Raj Kumar Gupta, resident of BB Das road, P.O. & PS- Purulia (T), District-Purulia. On 05.11.23 I received an order through my broker namely Bidya Singh who is the proprietor of Ma Durge Transco of Yadav Bhavan 1st floor new Kalimati road Sakchi, Jamshedpur, Jharkhand.
- 2. That, according to the said broker my truck having registration number NL 01AH 2674 will be provided by me to make the delivery of the goods i.e., slag iron from Om Enterprises Asanbani Channel, Saraikella Kharswana, Jharkhand to Alkia Enterprises 760, Chitadanga Majhi para Baktarnagar Andal, Paschim Bardhaman, West Bengal -713321.
- 3. According to the said broker my truck having registration number NL 01AH 2674 will be provided by me to make the delivery of the goods i.e., slag iron from Om Enterprises Asanbani Channel, Saraikella Kharswana, Jharkhand to Alkia Enterprises 760, Chitadanga Majhi para Baktarnagar Andal, Paschim Bardhaman, West Bengal -713321.
- 4. That, I accepted the said order of Rs. 45973.00(material value) in terms of the agreement, some rupees out of whole amount will be paid at the time of loading of slag iron. According to the said terms next day i.e. 06.11.23 my driver reached at Om Enterprise along with all goods and subsequently I got half of the payment through my said broker.
- 5. That, After that on next day i.e. 07.11.23 my driver delivered and unloaded the goods at the door of Alkia Enterprises and asked for the rest of amount of Rs. 19,000/-, then Mr. Saroj Kumar Roy of Alkia Enterprise denied to pay the



rest of amount to my driver, namely, Mubarak Ansary s/o Sk. Akbar Ansary resident of village Jhujka PS Arsha, District-Purulia.

- 6. That, As soon as my driver told me about the unfortunate incident, I was shocked. And called my broker and recited to him about the unfortunate occurrence of breach of Trust and fraudulent. Be it further mentioned that I also called Om Enterprise and both assured Me that I will be paid the rest of amount by them and further made various excuses. Furthermore several times I called my above named broker Om Enterprise and Mr. Saroj Kumar Roy of Alkia Enterprise but every time they are simultaneously ignoring my call and now they all are telling me to forget the pending money.
- 7. That, at the earlier occasion of said incident they accept their guilt and fraudulent activity and it clearly disclosed their mentality to cheat and which was pre planned. Be it mentioned that those conversations over voice calls are recorded and also saved on my own device as a evidence of Unfortunate fraudulent and cheating.
- 9. That, thereafter the complainant lodged a written complainant before Purulia(T) P. S. against the accused persons but the concern P. S did not take any action against the accused persons and lastly the complainant send his complaint through the speed post to the Inspector-in-charge of Purulia(T) P.S. On 19.01.24 and subsequently the same complainant has already been submitted before the Superintendent office Purulia by the present petitioner but even in spite of all these endeavours the complainant no step has not been taken by the police as such the complainant is being to compel the lodge this petition before your honour u/s 156(3) Cr. P. C.
- 10. That, thus the accused persons have committed offence u/s 406/4:7/420/120B and 34 IPC with the complainant and are liable to be prosecuted accordingly.







It is, therefore, most respectfully prayed that your Honour will be graciously pleased to accept this petition of the complainant and be further pleased to send this complaint to the Inspector-in-charge of Purulia(T) P.S. with a direction of investigate and the matter kindly be treating as written complaint or as a F.I.R.
