With due respect I beg to report that as per your kind endorsement Dated 04.03.24 I received Order No 18 dated 22.02.2024 passed by Ld. ADJ, 2<sup>nd</sup> Court (Spl. Court under NDPS Act.), Purulia in c/w Purulia (T) PS case No-160/23 dated-15.10.23, U/S-21(C)/29 NDPS Act, 1985 (N.D.P.S. Case No. 10 of 2023) alongwith copy of Report of Register of Death & Birth, Deben Mahato Govt. Medical College & Hospital, Purulia, copy of Order Sheet No. 16 dated - 09.02.2024 and copy of Birth Certificate of Sarfaraj Quraishi vide Reg. No. B-2024: 9-90347-003371 which is identified by S. Under the fact and circumstances I pray to you a cognizable case as per law may kindly be initiated against the parents of the accused person namely Sarfaraj Khureshi @ Quraishi @ Hairan (18Yrs) S/O- Aktar Khureshi @ Quraishi of Digudih para Ward-08, P.S- Purulia(T), Dist- Purulia and others who are involved in this offence.

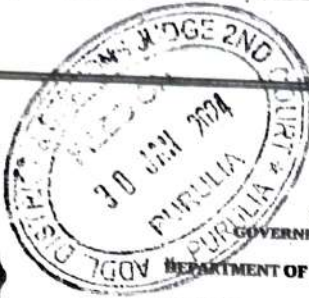
