Sub: Complaint against Niranjan Bauri, Akash Bauri and Nikhil Nandi to Nirdol Aam Party.

Sir,

I, Krishnanjan Ghosh, Son of Anjan Kumar Ghosh, resident at Majhipara, Mishan road, Purulia Municipality Ward No.5, Purulia-1, Purulia West Bengal-723101, would state the following facts:

I am hereby lodging a complaint before your alleging inter-alia that yesterday, at around 5:00pm., while passing through Nimtard Kabarsthan Road, that two person, namely, Niranjan Bauri and Akash Bauri threatened me to join and support Nirdol Aam Party. I am not the supporter of any political parties but Now Few days I am supporter of TMC party and I am joining with Ward No. 5 counsellor Bibhash Ranjan Das. That Niranjan Bauri and Akash Bauri forced me to join us but I am not interest to join Niranjan Bauri. So, firstly, Niranjan Bauri and Akash Bauri was beaten up with slaps and hits with the stick and Nikhil Nandi use subjected with slang / filthy / abusive languages. After that, Niranjan Bauri, Ajay, Rahul and also 10 to 15 person was tried to murder me by dangerous weapons. I tried to settle all the matters between us but at present at the evening situation has gone out of control Thus, after this situation local person rescued me and admitted in the Hospital

at Sadar Hospital, Purulia, at around 6:30pm. Niranjan Bauri staying in my locality and few days before he threatening me to come to my house and also used abusive/filthy languages and threats also killing me but that time I thought this is only political issue so I am not taking in seriously. But today I admitted and affecting my peace and safety and also my family in Danger and Niranjan Bauri was tried to murder me yesterday.

I thereafter inform I am passing my days and nights in the fear of getting murdered any time and disruptive noise during voting date released day and night in front of my house, verbal abuse and intentional damage to my property. The harassment had continued before one years and I feel threatened, one year before also I lodged a General Diary to Niranjan Bauri but that time he settled everything. Now, he started this and I very unsafe in my own house and not be safe.

I would humbly request you to take proper inquiry and investigation regarding the matter and treat this letter as the First Information Report and punish the accused in accordance with Law.

Your action and co-operation is highly appreciable.
