





4) That after marriage your petitioner went to her matrimonial house with her husband (accused No.1) in anticipating a peaceful, happy couple life and started living.

That after some days of their married life all her 5) hope converted to all but a nightmare. All the accused persons, with a joint hand started committing a unbearable unspeakable tortures upon your petitioner both mentally and physical when she started dreaming a happy life. 
