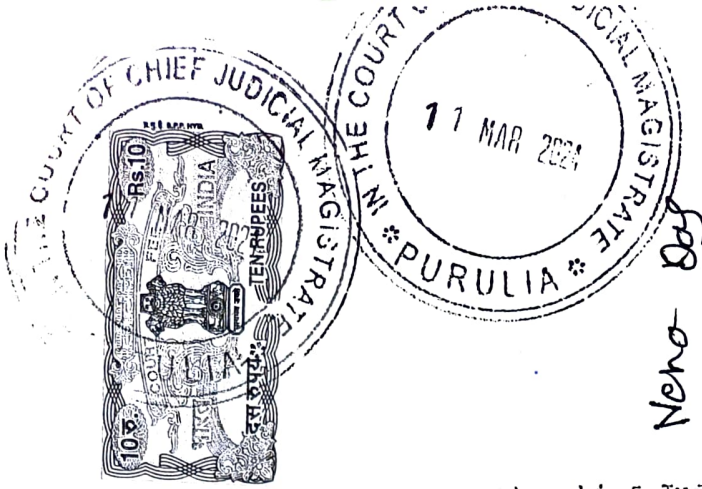

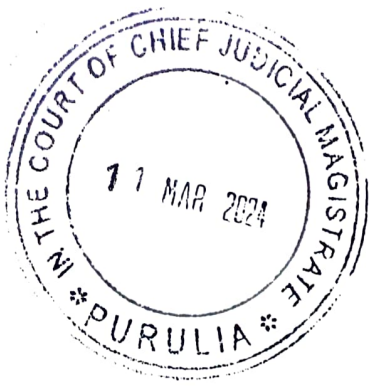

complainant i.e. your petitioner, as follows :-

- 1) That all the accused persons, witnesses are resident
of this Purulia District which are under your jurisdiction.
- 2) That your petitioner was married with the accused
No.1 on 18/02/2023 as per Hindu marriage Act, customs
prevalent in their society in presence of all the relatives,
friends of both the parties in the resident of her father.
- 3) That before and at the time of Marriage the father of
your petitioner, gave a cash of Rupees Two Lakhs, Ten
thousand Rupees as per their Dowry demand with Gold
ear ring (Jhumka) , Man tikly, Gold Padak, Silver Tora,

Bala waist Khoshmi, Taga , Box, ~~Ala~~ Alna ,Kichen set and other costly utensils, steel Divan, Brush Kalsi, Balti, Thala etc. in the hand of the father of accused No.-1 in presence of all present at the time of marriage, the marriage was solemnised Purulia Chowkbazar Kali Mandi at Main Road, Purulia on 18/02/2023.

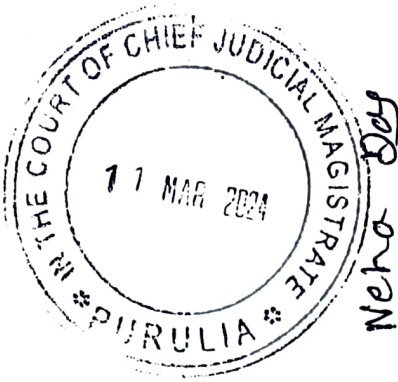
4) That after marriage your petitioner went to her matrimonial house with her husband (accused No.1) in anticipating a peaceful, happy couple life and started living.

5) That after some days of their married life all her hope converted to all but a nightmare. All the accused persons, with a joint hand started committing a unbearable unspeakable tortures upon your petitioner both mentally and physical when she started dreaming a happy life.

6) That nature of tortures being committed by all the accused persons was by keeping your petitioner without proper food, proper clothing ever she was not allowed to use any cosmetics. After some months of her marriage she was forced to lead a life of merely as maid servent only.

7) That all the accused persons other than accused no. 1 i.e. the husband used to provoke him to torture your petitioner and on their provocation the husband of your petitioner used to hackle your petitioner physically with

a violent mood in almost nights she stayed there.

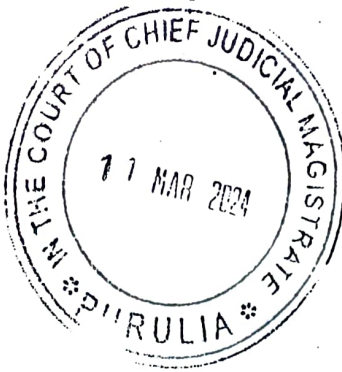
8) That on 06/08/2023 physical tortures committed by all the accused persons leaded by the accused No.- 1 the degree of physical tortures was so violent that your petitioner had to be admitted in the Purulia Sadar Hospital for urgent treatment where after treatment she was released on 08/08/2023.

9) That her health conditions was deteriorating day by day and at the same time, the accused No.1 and accused No.-2 i.e. the husband and mother-in-law of your petitioner tried to kill your petitioner by stopping her breath pressing her month by pushing a pillow. When your petitioner somehow cried for help, they left the place in a harsh.

10) That to save her life from those fureaus and rude, heartless accused persons, your petitioner called her father to rescue her from them and on the same day your petitioner reached her father's house on 08/08/2023 in the night and since than she has been living with them.

11) That on 05/01/2024 your petitioner filed a F.I.R. to the Inspector-in-charge Purulia (Town), but they did not take any action on the basis of that F.I.R.

12) That on being compelled your petitioner submitted a complaint, ^{Endored. P. Parulia} on 05/02/2024, but to no effect.

13) That all the accused persons with a joint intention committed above offence jointly which are punishable under appropriate sections of Law.

It is therefore prayed that your Honour would graciously be pleased to ~~ask~~ direct the Inspector-in-charge, Purulia Town Police Station to start a case treating this petition as F.I.R. as contemplated U/s. 156(3) Cr.p.c. to enable the accused persons face the trial in open court.
