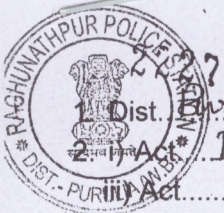

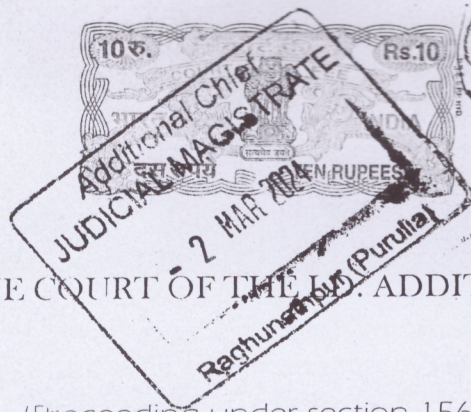

the complainant most respectfully beg to state as follows:-

1. that the complainant and the accused persons are the resident of Dist.- Purulia, W.B. and the incident took place within the jurisdiction of your Id. Court
2. the on 16/12/2023 at about 11.30 AM, when the complainant along with his wife ANNA BOURI was coming from Magalda to Raghunathpur through tempo having Registration no.- JH10AT7115, driving by SAMIUAL ANSARY S/O. SAKATALI ANSARI of village Hadalda, P.S.- Raghunathpur, Distt.- Purulia, W.B., due to rush and negligent driving of said SAMIUAL ANSARY, though he was warned by the complainant and later on meet with accident near village Bandanga, over Magalda-Raghunathpur Road, and for which the complainant sustain injury over his left sholder where the joint broke, along with lacerated injury in chest and left leg joint, with cut in chin and left ear. The wife of complainant namely ANNA BOURI also sustain injury over back side of head, chick and waist. It is pertinent to mention here that the driver SAMIUL ANSARY was talking over mobile in one hand and driving with other hand, with high speed in rush and negligent manner, for which the said tempo met with accident. And due to such accident, the complainant and his wife was taken to S.D. HOSPITAL, Raghunathpur, where complainant was admitted there and released after two days i.e. on 18/12/2023
