

Complainant respectfully sheweth:

1) That the RS plot no. 1484/1485/1486 within Kh no. 32 under Raghunathpur mouza owned, held and possessed by Satyabati Bhakat (deceased), W/o- Lt. Lakshminarayan Bhakat of Raghunathpur, Lal Bazar Para, who happened to be the Grandmother of the Complainant.

That Lakshminarayan Bhakat i.e. Grandfather of the Complainant during his lifetime transplanted several palm trees (খেজুর গাছ) which were sufficiently grown in the above mentioned plots owing to nourishment by the Grandfather of the Complainant, witness no. 2 & 3 are the sons of Grandparents of the Complainant.

That taking the advantage of absence of complainant and his father in the month of December 2023, accused person cut and took away as much as sixty palm trees from the above mentioned land without any consent/permission from actual owner of the above referred plots worth of Rs. 1,50,000/- only.
