Sir. In producing herewith one arrested accused person namely Laxman Bauri (40) S/o Lt. Madhu Bauri of Vill.- Banda, PO - Moutorh, PS - Raghunathpur, Dist.- Purulia under arrest along with seized articles as per seizer list i.e. (i) One white colour plastic jerican containing 08 (Eight) Ltrs. ID Liquor, (ii) 05 (Five) Pcs. Plastic Glass and (iii) One white colour plastic bottle containing 01 (One) Ltr. ID Liquor as sample taken from Sl. No. (i) under proper seizure with label.

I, SI Surajit Kr Das of Raghunathpur PS hereby lodged a written complaint against the above noted accused person to the effect that on 16.03.2024 during my evening mobile duty I received a credible source information that the above noted accused person was selling ID Liquor illegally in his house of the above noted accused near at Banda village under this PS. On receipt such information I immediately informed the matter to IC of the PS and as per his direction I along with force left to work out the information. At 19:45 hrs we reached at Banda village and my source shown the person from a distance who was selling the liquors. We immediately reached there and surrounded him, but other people who were assembled there to purchase liquor, on seeing Police Party, managed to flee away from the spot and found approx 08 (Eight) Ltrs. ID Liquor which was kept in a white colour plastic jerican at his house. On demand he failed to produce any license / authority of the said liquors. On interrogation he also made incoherent statement regarding possession of said liquors and told that he is usually selling the same to the villagers/pedestrian illegally. So, finding no any other alternative way I arrested him at 20:15 hrs after observing all the formalities as per law issuing memo of arrest as the accused person is liable for prosecution u/s-46A (c) of the Bengal Excise Act 1909 and I also seized the above noted articles from the possession of the accused person and labeled, duly singed by the accused person & witnesses in between 20:25 hrs to 20:55 hrs. During interrogation he confessed his guilt as such.

I therefore pray that a specific Case may kindly be started against the accused person namely Laxman Bauri (40) S/o Lt. Madhu Bauri of Vill.- Banda, PO - Moutorh, PS - Raghunathpur, Dist.-Purulia u/s-46A (c) of the Bengal Excise Act 1909.
