Sub: Prayer for lodging FIR against accused Manoranjan Mahata (32Y), S/O Mathur Mahatha of Vill. -Asurbandh, PS-Santaldih Dist- Purulia.

Sir,

In producing herewith arrested accused person named as Manoranjan Mahata (32Y), S/O Mathur Mahatha of Vill. - Asurbandh, PS-Santaldih Dist- Purulia along with seizure - list and seized items as described below, I beg to state that on 01.03.2024 at about 19.05 hrs, while Evening mobile duty, I received a source information to the effect that the foreign liquor / country spirit liquour has been kept at Raj Hotel near Deoli Panchayat under this PS in the hotel of above noted accused illegally, with an object to sale. I have informed the matter to I.C. Santaldih PS and this refers to Santaldih PS GDE no. 34 dtd. - 01.03.2024 and as per order of I.C Santaldih P.S. I along with force left for Raj Hotel near Deoli Panchayat to workout the information with the govt. supplied kit box containing white cloth, sealing wax, seal, papers, carbons, match box, candles etc. I had been to the Raj hotel at near Deoli Panchayet, P.S. Santaldih at about 19.15 hours. Seeing police party some unknown persons in front of the said hotel were fled away. However, I could detain one among of them and asked about his identity. He disclosed his name and identity as noted above and as well as admitted that he gathered the Foreign liquor / country spirit liquor for selling and he is the owner of the said hotel. However, I along with said accused started a search inside the said shop and found the following item in the said shop -

- 10 bottles of 650 ML of foreign liquor styled as Kingfisher each bottle containing 650 ML From which 01 bottle taken as sample.
- 10 bottles Country Spirit style as Dilkhus each bottle containing 600 ML From which 01 bottle taken as sample

I interrogated him about the purpose of the stocking and possessing such liquor. He replied it was the business of him. On repeated question he told that the person who fled away his customers (names of those not known to him). However he could not show any documents/papers in support of the possession as well as sale of the said articles.

As such, I seized the above items as ALAMAT under proper Seizure List between 19.35 hrs and 19.55 hrs & took up One bottle foreign liquor styled as Kingfisher 600 ML & One bottle C.S. (Dilkhus) 600 ML as samples, labeled and sealed accordingly.

Since the allegation against him of possessing, as well as selling the Foreign liquor / Country Spirit liquor illegally without any valid papers in the hotel has prima-facie been made out and for the interest of proper investigation, I arrested the above accused person at 20.00 hrs accordingly after maintaining all arresting guidelines.

Therefore, I pray before you to start a case under proper section of law against the accused Manoranjan Mahata (32Y), S/O Mathur Mahatha of Vill. - Asurbandh, PS-Santaldih Dist- Purulia
