Sub: Prayer for lodging FIR against accused (i) Mokbul Khan (62Y), S/O Lt. Golam Rasul Khan of Kanki Bazar, Hattola & (ii) Kashinath Mahato (47Y), S/O Lt. Parbati Mahato of Kanki Bazar, both of PS-Santaldih Dist- Purulia.

Sir

In producing herewith 02 (two) arrested accused persons named as (i) Mokbul Khan (62Y), S/O Lt. Golam Rasul Khan of Kanki Bazar, Hattola & (ii) Kashinath Mahato (47Y), S/O Lt. Parbati Mahato of Kanki Bazar, both of PS-Santaldih Dist- Purulia along with seizure – list and seized items as described below, I beg to state that on 01.03.2024 at about 19.55 hrs, while performing special mobile duty, I received a source information to the effect that the country spirit liquor has been kept at near Kanki Hattola under this PS in a unnamed shop of above noted accused illegally, with an object to sale. I have informed the matter to I.C. Santaldih PS and this refers to Santaldih PS GDE no. 35, dtd. – 01.03.2024 and as per order of I.C Santaldih P.S. I along with force left for Kanki Hattola to workout the information with the govt. supplied kit box containing white cloth, sealing wax, seal, papers, carbons, match box, candles etc. I had been to the unnamed shop at near Hattola, Kanki Bazar, P.S. Santaldih at about 20.05 hours. Seeing police party some unknown persons in front of the said shop were fled away. However, I could detain two (02) among of them and asked about their identity. They disclosed their name and identity as noted above and as well as admitted that they gathered the country spirit liquor for selling. However, I along with said accused started a search inside the said shop and found the following item in the said shop -

- 15 bottles Country Spirit style as Dilkhus each bottle containing 600 ML From which 01 bottle taken as sample.
- 10 bottles Country Spirit style as Dilkhus each bottle containing 375 ML
 From which 01 bottle taken as sample

I interrogated them about the purpose of the stocking and possessing such liquor. They replied it were the business of them. On repeated question they told that the persons who fled away were their customers (names of those not known to him). However they could not show any documents/papers in support of the possession as well as sale of the said articles.

As such, I seized the above items as ALAMAT under proper Seizure List between 20.25 hrs and 20.45 hrs & took up One bottle C.S. (Dikhus) 600 ML & One bottle C.S. (Dikhus) 375 ML as samples, labeled and sealed accordingly.

Since the allegation against them of possessing, as well as selling the Country Spirit liquor illegally without any valid papers in the unnamed shop has prima-facie been made out and for the interest of proper investigation, I arrested the above accused persons at 20.50 hrs accordingly after maintaining all arresting guidelines.

Therefore, I pray before you to start a case under proper section of law against the said accused (i) Mokbul Khan (62Y), S/O Lt. Golam Rasul Khan of Kanki Bazar, Hattola & (ii) Kashinath Mahato (47Y), S/O Lt. Parbati Mahato of Kanki Bazar, both of PS-Santaldih Dist- Purulia.
