Sub: Prayer for lodging FIR against accused Basudeb Hazra (45 Yrs) S/O - Dhaneswar Hazra of Vill. - Gohira, PS-Santaldih Dist-Purulia. Sir.

In producing herewith one arrested accused person named as Basudeb Hazra (26 Yrs) S/O Dhaneswar Hazra of Vill. - Gohira, PS-Santaldih Dist- Purulia along with seizure - list and seized items as described below, I beg to state that on 16.03.2024 at about 20.15 hrs, while performing evening mobile duty, I received a source information to the effect that the Country spirit & foreign liquor have been kept at Paharigora under this PS in the hotel of above noted accused illegally, with an object to sale. I have informed the matter to I.C. Santaldih PS and this refers to Santaldih PS GDE no. 708 dtd. - 16.03.2024 and as per order of I.C Santaldih P.S. I along with force left for Paharigora more to workout the information with the govt. supplied kit box containing white cloth, sealing wax, seal, papers, carbons, match box, candles etc. I had been to the hotel of Basudeb Hazra at Paharigora, P.S. Santaldih at about 20.35 hours. Seeing police party some unknown persons in front of the hotel of Basudeb Hazra were fled away. However, I could detain one among of them and asked about his identity. He disclosed his name and identity as noted above and as well as admitted that he gathered the foreign liquor for selling and he was the owner of the said hotel. However, I along with said accused started a search inside the hotel of Basudeb Hazra and found the following item in the said hotel -

- 06 bottles Foreign liquor style as kingfisher each bottle containing 650 ML From which 01 bottle taken as sample.
- 18 bottles Country Spirit style as Dilkhus each bottle containing 600 ML From which 01 bottle taken as sample.

I interrogated him about the purpose of the stocking and possessing such foreign liquor. He replied it was the business of him. On repeated question he told that the persons who fled away were his customers (names of those not known to him). However he could not show any documents/papers in support of the possession as well as sale of the said articles.

As such, I seized the above items as ALAMAT under proper Seizure List between 21.05 hrs and 21.25 hrs & took up one of foreign liquor style as kingfisher of 650 ML & One bottle C.S. (Dikhus) 600 ML as samples, labeled and sealed accordingly.

Since the allegation against him of possessing, as well as selling the foreign liquor & Country Spirit liquor illegally without any valid papers in his hotel has prima-facie been made out and for the interest of proper investigation, I arrested the above accused at 21.30 hrs accordingly after maintaining all arresting guidelines.

Therefore, I pray before you to start a case under proper section of law against the said accused Basudeb Hazra (45 Yrs) S/O - Dhaneswar Hazra of Vill. - Gohira, PS-Santaldih Dist- Purulia.
