Respected sir,

In producing herewith the 02 arrested accused persons namely (i) Nayan Bauri (33Y), S/O Lt. Kalipada Bauri of Vill. - Amchatar and (ii) Chhutulal Bauri (35Y), S/O Fani Bauri of Vill. - Adda, both of PS - Santaldih, Dist. - Purulia and 02 (Two) seized tractors i.e. (i) One tractor (Mahindra 275DI) having registration no. WB55/5761 attached with trolley loaded with sand approx 100 CFT and (ii) One tractor (Swaraj 735 FE) having registration no. WB55/1971 attached with trolley loaded with sand approx 100 CFT and also produced Seizure List. The nub of the fact in a nutshell is that today (21.03.2024) while I, along with C/1384 Daman Ch. Gorai & C/Durga Charan Mahato, were performing day mobile duty vide Santaldih PS GDE no. 902, dated 21.03.2024, at Santaldih PS area, I, received a tip off at 12:15 hrs, that 02 tractors were illegally carrying sand from Gowai river bank near Matir Sristi Prokolpo, Parbahal village and going towards Belkura village. Subsequently, I informed the matter to IC Santaldih PS and Duty officer vide Santaldih PS GDE No 916 dated 21.03.2024 and as per direction of IC Santaldih PS I along with force proceeded towards Parbahal village to work out the tip off. While, I along with force arrived at near Parbahal village road under Santaldih PS and found that, 02 (two) tractors as identical as received prior information coming from Parbahal village side towards Belkura village side.

Subsequently, I, along with force proceeded to detain the tractors and reached at the spot i.e. Parbahal village road, PS - Santaldih at 12:35 hrs but seeing the police persons the drivers of the tractors tried to flee away with tractor loaded with sand and we apprehended them. On being asked, they disclosed their name and address as (i) Nayan Bauri (33Y), S/O Lt. Kalipada Bauri of Vill. - Amchatar and (ii) Chhutulal Bauri (35Y), S/O Fani Bauri of Vill. - Adda, both of PS - Santaldih, Dist. - Purulia but unable to produce any valid documents in respect of the said tractors as well as loaded sand in it. They also stated that as per consent with the owners of the both tractors, they are running this business by means of illegal transportation of sand for their wrongful gain.

During enquiry, it is ascertain that the drivers of the said tractors loaded the said sand in cahoots with the owners of the vehicles (tractor) by illegal means for selling the same to make profit by dishonestly and they had been running a clandestine business by transporting the same at Jharkhand State. So, it is reason to believe that they in cahoots with the owner of the vehicles procured the said sand from Gowai river bank near Matir Sristi Prokolpo, Parbahal village by fraudulently means or theft by any means for transporting the same at Jharkhand State to run clandestine business. As per source information, they have been engaged in the said illegal sand lifting business since long behind the eyes of the administration.

So, I arrested the above noted accused observing all arresting guidelines. During interrogation they also confessed their guilt in this case. I also seized the above noted tractors along with trolley loaded with sand with proper seizure list duly signed by witnesses. On demand they failed to produce their driving license. Thereafter, I brought the arrested persons and the seized tractors along with the loaded sand into the trolley to Santaldih PS.

Under above fact and circumstances, I, pray before you to start a specific case against the above noted driver namely (i) Nayan Bauri (33Y), S/O Lt. Kalipada Bauri of Vill. - Amchatar and (ii) Chhutulal Bauri (35Y), S/O Fani Bauri of Vill. - Adda, both of PS - Santaldih, Dist. - Purulia and the owner of the above noted tractors i.e. (i) One tractor (Mahindra 275DI) having registration no. WB55/5761 and (ii) One tractor (Swaraj 735 FE) having registration no. WB55/1971 under proper sections of law.
