Sub: Prayer for lodging FIR against accd. Krishnapada Gorain @ Ganrai (47 yrs) S/O – Lt. Barun Gorain @ Ganrai of Vill-Ichhar, PS-Santaldih Dist-Purulia, U/S 46A (c) B.E. Act 1909.

Sir,

In producing herewith arrested accused Krishnapada Gorain @ Ganrai (47 yrs) S/O - Lt. Barun Gorain @ Ganrai of Vill- Ichhar, PS-Santaldih Dist- Purulia, along with 31 bottles seized country spirit styled as "DIL SE" 600 ml in each bottle and 04 bottles seized Imperial Strong Beer styled as "KINGFISHER" 650 ml in each bottle. I beg to state that today i.e on 25.03.2024 I am performing duty at Santaldih IC BCW area in c/w Holi festival. This refers to Santaldih I/C BCW GDE No- 517 and SPL. C.C No- 36/2024 of dated 25.03.2024. Then at 20:25 hrs acting on a tip off I along with force had been to the house of Krishnapada Gorain @ Ganrai (47 yrs) S/O - Lt. Barun Gorain @ Ganrai of Vill- Ichhar, PS-Santaldih Dist- Purulia. I along with force held raid in the house of Krishnapada Gorain @ Ganrai. Seeing police van some unknown persons coming out from the house of Krishnapada Gorain @ Ganrai and fled away. However I could be able to intercept Krishnapada Gorain @ Ganrai. On search found 31 bottles country spirit styled as "DIL SE" 600 ml in each bottle and 04 bottles seized Imperial Strong Beer styled as "KINGFISHER" 650 ml in each bottle in his house. I also found approx 10 empty bottles of country spirit styled as "DIL SE" scattered at the courtyard of his house. On asked he failed to produce any valid documents in respect of possessing and selling of country spirit and beer in his house as well as he confessed his guilt. Accordingly I seized and labeled 31 bottles of country spirit styled as "DIL SE" 600 ml in each bottle and 04 bottles seized Imperial Strong Beer styled as "KINGFISHER" 650 ml in each bottle under proper seizure list in presence of witnesses duly signed by them. Out of seized bottles country spirit 01(One) bottle "DIL SE" and 01 (one) bottle "KINGFISHER" are kept as sample. I also arrested the accd. Krishnapada Gorain @ Ganrai (47 yrs) S/O - Lt. Barun Gorain @ Ganrai of Vill-Ichhar, PS-Santaldih Dist-Purulia.

However the accd. Krishnapada Gorain @ Ganrai committed offence U/S 46 A (c) B.E Act, 1909 for possessing and selling of country spirit in his house without any valid documents.

Therefore, I pray before you that a case may be started against accd. Krishnapada Gorain @ Ganrai (47 yrs) S/O – Lt. Barun Gorain @ Ganrai of Vill- Ichhar, PS-Santaldih Dist- Purulia under proper section of law.
