Respected Sir,

With due respect I Priyanka Chakraborty D/O Kanchan Chakraborty of Vill-Beliapur , P.O- Pachhandapur, Beliapur, P.S-Santuri, Dist- Purulia beg to draw your kind attention that on 10.03.24 at about 7.30 pm while my father Kanchan Chakraborty @ Lafar s/o- Late Fakir Chakraborty was returning home from Sanuri by riding his Motor cycle bearing Reg. no WB-82-1388 through Madhukunda-Saltora Road , from the left side of the road. On way when he reached at Amit Hotel (Chandurdi) near Madhukunda Railway Station at that time one Bollero four wheeler bearing Reg no **WB-38-AV-0378** dashed my motorcyclist father from behind with high speed in a rash & negligent manner of driving. As a result of such accident, my father fell down on road and got sustained grievous injuries on his person. Thereafter with the help of local people he was shifted to Harmadih Gramin Hospital at Harmadih under- P.S Neturia where his condition was detoriate and concerned Doctor declared him dead on 10.03.24.

Over this incident P.M was done on 11.03.24 , Nituria P.S UD case no 03/24 Dated 10.03.2024.

The accident took place due to rash, high speed and negligent manner of driving by the driver of offending bolero no **WB-38-AV-0378**. I am hereby requesting you to investigate the matter as per Law and lodge FIR in this regard and do oblige.

That due to said accident I was mentally shocked and also funeral ceremony it is delay to submit this matter complaint before you.
