To, The Officer-in-Charge, Tamna P.S.,

Sir,

With due regard, I, Md. Faisal Hussain, Son of Md. Lal Hussain, a resident of Kasai Mohalla, J.K. College Road, Purulia, P.O. & District-Purulia, W.B. beg to inform you that I am an owner & possessor of R.S./L.R. Plot No.626, 627, 628, 629, 772, 785, 786, 787, 788, 790, 792, & 795 of Mouza-Belguma (J.L.No.41) within Tamna P.S. in the district of Purulia & the said property recorded in the name of my grandmother Sahidan Bibi, & Mahidan Bibi & Nasiban Bibi being wives of Daud Khan.

Recently, some persons namely Alam Khan, Nanhe Khan both Sons of Mahmud Khan, Samim Khan, Son of Anowar Khan, Asif Khan Son of Nanhe Khan, Safi Alam Khan, Son of Alam Khan & Shahjada Khan & Sanowar Khan Son of Manowar Khan, along with some men of J K College Road, Purulia, P.S.-Purulia(T), District-Purulia, were creating disturbances over my share of properties and they are trying to dispossess me from my legitimate share by using force. The said persons falsely claiming that the aforesaid Plot was originally belonged to Mahmud Khan & they, being the legal heirs of Mahmud Khan, are claiming their own. It is to be mentioned here that said Mahmud Khan during his lifetime transferred properties to several persons & accordingly Mahmud Khan had no property left in the said Plot.

One Suja Ali Khan @ Kusmat Khan had two sons namely Nusrat Ali Khan & Daud Khan & said Daud Khan expired by leaving behind three wives namely Mahidan Bibi, Sahidan Bibi & Nasiban Bibi. Mahidan Bibi & Nasiban Bibi expired long ago being issueless and their properties devolved upon another wife of Daud Khan namely Sahidan Bibi. While Sahidan Bibi was in possession over her properties she transferred the same to myself being grandson by way of gift.

The aforesaid persons being legal heirs of Nusrat Ali Khan manufactured several documents so as to grab my properties. From reliable sources I came to learn that the aforesaid persons as per their requirements obtained several legal heir certificates from the Purulia Municipality & Sonaijuri G.P. in respect of the family of Suja Ali Khan @ Kusmat Khan by giving every time false details.

The aforesaid persons obtained said valuable documents by false representation & also by fraudulent means by suppressing original facts so as to grab my properties with intent to cause damage or injury to me to support their illegal claim by depriving me from my legitimate share of properties & also with intent to commit fraud upon me. The aforesaid persons forged several documents including the aforesaid documents as per their choice so as to grab money from the Land Acquisition Department, Purulia towards compensation for acquiring portion of the said property, knowing fully well that the said documents are not genuine. I strongly believe that the aforesaid persons manufactured such documents with intent to cheat me as well as other authorities on the basis of such forged & manufactured documents.

It is to be mentioned further 0n 09/03/2024 at about 9 AM, I went to my properties & found that the aforesaid persons namely Alam Khan, Nanhe Khan both Sons of Mahmud Khan, Samim Khan, Son of Anowar Khan, Asif Khan Son of Nanhe Khan, Safi Alam

Khan Son of Alam Khan, Shahjada Khan & Sanowar Khan, both Sons of Manowar Khan, are assembled near the properties with some ill intent, I requested them not to indulge in such matter on the basis of several false documents, but they threatened me with dire consequences & asked me to left the Place. I raised objection when upon the said persons became furious & caught hold me & assaulted me with feast & blows. They also caught hold my neck for strangulation with intent to kill me but Md. Raju Qurashi, Soumen Gorain, Shankar Singh, Monu Qurashi, Safique Ansary & others appeared to rescue me when upon said persons left the place. The aforesaid persons are very much adamant to take law at their own hands & due to such threat I am afraid of my life.

After such incidents the persons so assembled there, rescued me, & took me to Deben Mahato Sadar Hospital, Purulia, where the doctor admitted me & treated me. Though on 11/03/2024, I got release from the Hospital, but I am not fully fit & the doctor adviced me to take rest.

I, therefore request you to take step against the aforesaid persons being wrong doers so that they may be punished for their illegal activities.
