That the complainant most respectfully beg to state as follows:-


- 1. That the complainant and her husband used to live within Adra PS and passing their old aged life upon the pension received by complainants' husband from railway.
- 2. That the complainant have two son namely MONIR KHAN & SONIR KHAN (since deceased) with one married daughter, whereas MONIR KHAN, after his marriage, used to reside at Rly Ort. No. DS/105/B with his wife and two sons since 08/01/2021







- 3. That the voilinger son namely SONIR KHAN (since deceased) of the complainant got married with CHANDNI KHATOON on 20/02/2021, as per Muslim Law and after being married said CHANDNI KHATOON came to reside with the complainants' family at village chunabhati, where the complainant and his husband and son SONIR KHAN and said CHANDNI KHATOON used to reside under common roof and mess.
 - 4. That said CHANDNI KHATOON is a graduate lady, whereas said SONIR KHAN (since deceased) is class IX passed, and within a short span of time, over matter of education, on and often a quarrel taken place between them and for which she left SONIR KHAN within 10 days of their marriage and started to reside with her father at Kumardhubi, Dhanbad, Jharkhand.
 - That the deceased son SONIR KHAN of the complainant, several time tried his best to brought his wife back, but she refused to come and started a job in Private School at Egarkunr, Dhanbad.
 - That said CHANDNI KHATOON, out of their marriage, give birth of child at Dhanbad in the month of November 2021.
 - 7. That after birth of grandson of the petitioner, her deceased son SONIR KHAN tried his best to bring his wife i.e. CHANDNI KHATOON and in the month of March 2023 said CHANDNI KHATOON came to Chunabhati, Adra with minor child and after staying for seven days, she again returned to her parents house at Kumardhubi, Dhanbad.
 - That on the request of SONIR KHAN said CHANDNI KHATOON again come to the house at Chunabhati, Adra on 21/01/2024 and used to live with SONIR KHAN.
 - That after coming of said CHANDNI KHATOON, at Chunabhati, Adra, within a
 week, the complainant/petitioner heard a dispute between his son SONIR KHAN
 with CHANDNI KHATOON, as she started demanding to return back to
 Kumardhubi, Dhanbad.
 - 10. That on 03/02/2024, at about 1.30 PM, when the petitioner/complainant and her husband was on the roof of their residential house, due to winter season, heard a quarrel between SONIR KHAN with CHANDNI KHATOON, where said CHANDNI KHATOON was demanding SONIR KHAN to take her back to Kumardhubi as she is not willing to stay at Chunabhati, Adra with other family members where said SONIR KHAN requested CHANDNI KHATOON not to leave him as their marital life is not going well due to stay at her parents house at Kumardhubi.
 - 11. That the complainant heard that said CHANDNI KHATOON demanding his son to send her back to Kumardhubi, on the very date, where his son SONIR KHAN requested her not to leave as the complainant is a Asthma patient and her husband MD. JAMIL AKHTAR KHAN who is paralyzed person aged about 75 years, are solely depend upon SONIR KHAN for their day to day life, amd then said CHANDNI KHATOON says SONIR KHAN "TUM KO IN LOGO KE SAATH MARNA HAI MARO, MAI CHALI BACCHE KO LE KAR AUR MAI NAHI ANE







WALL YAHA", and within 5 to 10 minutes, when complainant came down from roof, foundathat her son was in hanging condition with ceiling fan and said CHANDNH KHATOON shouted as "MUJHE DARA MAT TERA NATAK JANTI HU".

- 12. That seeing the condition of SONIR KHAN, the complainant hold the hanging legs of her son for support and shouted for help, where the neighbor came and tried to rescue SONIR KHAN and took him to Raghunathpur S.S. Hospital, where he was declared dead.
 - That the complainant believe that due to abatement of said CHANDNI KHATOON, his son has committed suicide.
 - 14. That the complainant had informed the matter to the police personal on 03/02/2024, as they came to their house on the date of suicide of her son SONIR KHAN, but till today no action has been taken by the concern police authority against CHANDNI KHATOON.
 - 15. That due to inaction by the local PS, the complainant made written complainant to I.C., Adra P.S. ON 20/03/2024 and also to S.P. Purulia 20/03/2024, with other respective authority but till today no fruitful result came out.
 - 16. That finding no other alternative the present complainant took the shelter of the ld. court for the redressal of her grievance.

It is therefore prayed before the Id. Court may kindly allow this petition treating the same U/S 156(3) of Cr.P.C., and to pass necessary order/orders, direction/directions, to the Inspector In Charge, Adra Police Station to treat the same as F.I.R. against the above named accused persons and any other order/orders, direction/directions, as your Id. Court may deem fit and proper for the ends of Justice, And for this act of kindness the complainant shall ever prays.
