P.S - Arilova Police Station, Dist - Visakhapatnam, State - Andhra Pradesh. On 2022 at Raghunathpur court for Domestic violence and also Divorce process had been going on Visakhapatnam court. My son G.E. Vahamala Tushar Kumar (Age 6 yrs) has been staying with me in Admn. He is a student of Public School Admn, on 26/04/2024 as usual he went to school on 6:30 A.M, After that my son has not been returned from school. I along with my father tried to find every where but could not find any where. I suspected that my husband kidnaped my child and took with him. I also suspected that other than him more person were involved in this kidnaping.

Previously I appointed one person G.E. Sibuboin son of Badal Boin of Wathi side Tetric colony P.S Admn. Dist - Purulia. For took my son from home to school during school hours. He always concerted with my husband and always informed my husband about my child school timing and other movement. After my enquiry one person Krishna Mukhi (School Staff of Admn Public School) confirmed that my husband kid took my child with him during school hours.
