I, Sukhendu Mudi, S/O-Lt.Mrityunjoy Mudi, Age-45years , AE & Station Manager, Arsha CCC,WBSEDCL, do hereby lodge complaint empowered by enabling the electricity act 2003 subsequently, the amendment act 2007 to the effect that Kanai Mandal S/O- Akshay Mandal of Village - Rugri, PS-Arsha,Dist-Purulia has committed theft of electricity U/S 135(1)(b) of electricity act 2003 subsequently amendment act 2007.

On 05.04.2024 at about 11.30 am I, along with Alimuddin Ansary,S/O-Late Miyazan Ansary, Age-42 years, Sr. TSH, Arsha CCC, and Chandan Mahato, S/O-Late Phanibhusan Mahato, Age-36years , TSH Arsha CCC under Purulia Division went to routine inspection in Rugri Village and entered the premises of Kanai Mandal S/O- Akshay Mandal of Village -Rugri, PS-Arsha,Dist-Purulia consumer bearing Id-242258592 and found that Kanai Mandal S/O- Akshay Mandal was enjoying electricity from incoming wire of meter by breaking the seal of the energy meter . The service connection of Kanai Mandal S/O- Akshay Mandal with Meter No.DDG347512 disconnected on the spot from nearby LTOH Line of WBSEDCL .The inspection team left the premises of the accused person at about 12.00 pm.

Kanai Mandal S/O- Akshay Mandal of Village -Rugri, PS-Arsha,Dist-Purulia has committed an offence U/S 135 (1)(b) electricity act 2003(Amendment Act 2007),so you are requested to take cognizance of this complaint and treat it as FIR.
