I, Sukhendu Mudi, S/O-Lt.Mritunjoy Mudi, Age-45years , AE & Station Manager, Arsha CCC, WBSEDCL, do hereby lodge complaint empowered by enabling the electricity act 2003 subsequently, the amendment act 2007 to the effect that Ananda Mahato S/O- Late Kamal Mahato of Village -Asaramdih, PS-Arsha, Dist-Purulia has committed theft of electricity U/S 135(i)(a) of electricity act 2003 subsequently amendment act 2007.

On 18.04.2024 at about 01:35 p.m I, along with Partha Chakraborty, S/O-Late Dinabandhu Chakraborty, D.E (S&LP), Purulia Regional Office, Dayamay Mahato, S/O-Late Chhutulal Mahato, Sr.TSH(S&LP), Purulia Regional Office, Alimuddin Ansary, S/O-Miyazan Ansary, Sr. TSH, Arsha CCC went to routine inspection in Asaramdih Village and entered into the premises of Ananda Mahato S/O- Late Kamal Mahato of Village -Asaramdih, PS-Arsha, Dist-Purulia and found that Ananda Mahato S/O- Late Kamal Mahato was enjoying electricity unauthorisedly by direct hooking from LTOH Line of WBSEDCL in his domestic premises. The hooking connection of Ananda Mahato S/O- Late Kamal Mahato was disconnected on the spot from nearby LTOH Line of WBSEDCL. During inspection we found the electrical load he is enjoying as 0.500 KW. The inspection team left the premises of the accused person at about 02:00 p.m.

Ananda Mahato S/O- Late Kamal Mahato of Village -Asaramdih, PS-Arsha, Dist-Purulia has committed an offence U/S 135(i) (a) electricity act 2003 (Amendment Act 2007), so you are requested to take cognizance of this complaint and treat it as FIR.
