

Sir.

In producing here with one arrested accused Dilip Mahato (35 yrs) S/O Lt. Kalipada Mahato of vill- Hensla, P.S.-Arsha Dist-Purulia, along with following seized articles.

1) One white colour plastic container with approx 14 ltrs. of ID liquor. (Approx 500 ml taken out from of the above container as sample packed with sealing wax)

I. ASI Amal Kr. Pati of Arsha PS do hereby lodge a written complaint against the above noted accused person to the effect that today i.e 21.04.2024 at about 18.15 hrs. during my Spl. mobile duty at PS area, received source information over telephone that the above noted accused has been selling ID liquor in his house at Hensla village. On receiving the reliable source information, I communicated with O/C Arsha PS over telephone and as per his instruction I along with i) C/-223 Kamakhaya Majee and ii) C/- 192 Pintu Sharma both of SAP 7th BN camp at Arsha PS, rushed in the house of Dilip Mahato (35) yrs) S/O Lt. Kalipada Mahato of vill- Hensla, P.S.-Arsha Dist-Purulia to work out the information vide Spl. C.C No.1190 dtd.21.04.2024 & Arsha PS GDE No. 881 Dtd. 21.04.2024. Reaching at Hensla village at about 18.55 hrs, we fixed-up in the house of above noted accd. person Dilip Mahato (35 yrs) S/O Lt. Kalipada Mahato of vill- Hensla, P.S.-Arsha Dist-Purulia and found that selling of ID Liquor was going on there and having seen police all customers managed to escape but we were able to apprehend the above noted accused person. On demand of showing papers, he failed to produce any valid documents in support of selling ID liquor. So, I seized all the implicating articles as noted above under a proper seizure list from his exclusive possession in presence of witnesses and properly sealed and labeled duly signed by the accused person and witnesses among which approx 500 ml taken out from the above container as sample packed with sealing wax with label. During interrogation he confessed his guilt. So, I arrested him after observing all the formalities issuing memo of arrest as he was selling ID liquor illegally.

I therefore pray that a specific case may kindly be started against the accused Dilip Mahato (35 yrs) S/O Lt. Kalipada Mahato of vill- Hensla, P.S.-Arsha Dist-Purulia under proper section of law.
