Sub: Lodging of F.I.R of theft of Electricity against Shantibala Bhagat, W/o Lt. Dhananjay Bhagat at her Domestic premises at Vill.-Suisa, P.S.-Baghmundi and thereby committed an offence punishable U/S 135(1)(b) & (1)(d) of Electricity Act 2003 amended in 2007.

Dear Sir.

This is to inform you that, I Sri Maruti Mahato (44), S/O – Paban Chandra Mahato, A.E. & Station Manager of Baghmundi CCC of WBSEDCL received an information to the effect that Shantibala Bhagat, W/o Lt. Dhananjay Bhagat residing at Vill.- Suisa was committing theft of Electricity at her Domestic premises by bypassing the proper registration of units by tampering the Energy meter.

Acting on this information this day 01.04.2024, I alongwith Sri Anup Mondal, J.E. GrI(E) of Bagmundih CCC, Sri Subhasis Mahato, Sr.O.E. of Bagmundih CCC, Sri Biswajit Kumar, TSH of Bagmundih CCC had been to the house of Shantibala Bhagat at the above mentioned address. Her son was present at house. We contacted him and disclosed our identity to him. On being asked he allowed us to inspect the Energy meter of WBSEDCL installed at his domestic premises against the name of the consumer namely Shantibala Bhagat.

Also search for local people as witnesses during our inspection of the Energy meter of the said premises but none came forward though some local people gathered there. The premises was a two storied building and the meter is installed at the entrance of that premises. Immediately, a notice was prepared which her son to sign served upon him and held inspection but Inspection sheet and seizure was signed.

During inspection, it was detected that, Shantibala Bhagat had tampered the energy meter installed at Domestic premises bearing meter No: L2281558 in the name of Shantibala Bhagat at the said premises to bypass the proper registration of units by tampering the meter circuit of the meter and seals of the said meter to commit theft of Electricity. Inspection also revealed that Shantibala Bhagat was the actual user of the above mentioned service connection.

Immediately, on my direction Sri Biswajit Kumar, TSH of Bagmundih CCC disconnected the above mentioned service connection and removed the Energy meter bearing SI no: L2281558 after securing the installation place of the said meter from any imminent danger in future. Dilip Bhagat i.e. her son was shown the tampered meter but being asked he could not render any satisfactory explanation. She was informed about the offence committed by her son and its penal provision.

Sri Anup Mondal, JE GR I(E) of Bagmundih CCC prepared inspection report in his presence and witnesses at the spot and load assessed as 1.3KW. The details of inspection has been mentioned in the inspection sheet attached herewith.

From the evidence so far collected from the inspection of the energy meter of Shantibala Bhagat, it is well established that Shantibala Bhagat was consuming Electricity illegally in her Domestic residence and for this activity of theft the WBSEDCL has incurred huge loss of revenue.

Sri Anup Mondal, JE GR I(E) of Bagmundih CCC prepared Seizure list in respect of the said premises and meter in presence of the consumer and witnesses at the spot.

The inspection was held between 05:00PM to 05:20PM today after observing all legal formalities.

It is well evident that accused Shantibala Bhagat, W/o Lt. Dhananjay Bhagat of Vill.-Suisa has committed offence punishable U/S 135(1)(b) & (1)(d) of Electricity Act 2003 amended in 2007.

You are requested to take cognizance of this complain & treat it as FIR
