

I would like to inform you that my daughter Kulsum
Sadique was married with Yasir Arafat Son of Aftab Momin.
Address Vill Humunda P.S Baghmundi dist. Purulia on 31.01.24
Since after their marriage she was subjected to torture mentally
physically both by her husband father in-law and mother in-law
Yasir Arafat (husband), Aftab Momin (father in-law) and Nasila
Bibi (mother in-law). To day on 25.04.24 at about 04:30PM got a
call from daughter's father in-law Aftab Momin, who told me
that daughter Kulsum Sadique was committed suicide by
hanging, and when we took her Patherdih B.P. H.C where
attending AIO declared her brought dead.

My daughter Kulsum always complaint me that her
husband, father in-law, and mother in-law regularly tortured
her for more darry and they always do her character
assassinated. After got the news we rushed to Patherdih
B.P.H.C and found her dead body was laying condition.


Due to low financial condition of mine I was unable
