I, LASI Kabita Murmu along with force returned to P.S and brought 01 (one) seized Tractor attached with a trolley as One Red colour Tractor Engine having registration No- WB55A/7267 (Model- Mahindra 475DIMKMBLX), Chassis No-MBNABAJAKHJG01266, Engine No- NHF2KBJ1031 loaded with approx 50 cft. sand. The fact in brief is that today (22.04.2024) I along with force namely C/2419 Kanai Soren, C/476 Bishnu Bala and CD/234 Bisam Hansda were performing mobile duty at Balarampur P.S area vide Balarampur P.S GDE No- 1041 Dated- 22.04.2024 in c/w Balarampur P.S C.C No- 1522 Dated- 22.04.2024. During my mobile duty I received a credible source information that the Tractor engine was lifting & carrying sand illegally and coming from Sirkabad village side through Panradda village side Pitch road which is coming towards Balarampur. Subsequently, I informed you and as per your order, I work out the said information. Thereafter myself along with force held raid at Sirkabad village near small river and found the above noted tractor was proceeding towards Balarampur. Consequently, when we intercepted the said Tractor at about 18:05 hrs but seeing the Police party, the said tractor along with sand loaded trolley turned around and flee away from there. We manage to apprehend the said above noted tractor and we were able to detain the said tractor but the driver of above noted tractor flee away. We tried to apprehend him but failed. We waited for reasonable time but none came to spot. It was ascertained that the driver of the tractor loaded the said sand in cahoots with the owner of the Tractor by illegal means for selling the same to make profit by dishonestly and he had been running a clandestine business. So it is reasonable to belief that he in cahoots with the owner of the offending tractor procured the said sand from small River under Balarampur P.S area by fraudulently means or theft by any means for transporting the same to run clandestine business. So I, seized the tractor attached with a trolley as One Red colour Tractor Engine having registration WB55A/7267 (Model-Mahindra 475DIMKMBLX), MBNABAJAKHJG01266, Engine No- NHF2KBJ1031 loaded with approx 50 cft. sand Chassis under proper seizure list in presence of witnesses duly signed by him. Thereafter, I brought the said tractor engine along with a sand loaded Trolley to Balarampur P.S

Under the above facts and circumstances kindly take lawful action against the Owner & driver of the said offending tractor Engine and sand loaded trolley as he committed offence U/S 379/411/414 of the IPC & 21 (1)(4) Mines and Minerals (R&D)
