Dear Sir,

I do hereby lodge complaint empowered by enabling The Indian Electricity Act – 2003, subsequently Electricity (Amendment) Act 2007 to the effect that Budhu Hembram, S/O – Bistu Hembram, Vill –Bhurudanga, PO - Dhadka, PS – Bundwan, Dist – Purulia has committed theft of electricity U/S 135/1/b of The Electricity Act.

On 04/04/2024 about 17:10 Hrs, I, Prashanta Mandal, AE&SM, Bundwan CCC, WBSEDCL, along with, Subhankar Majumdar, Sr. TSH, Bundwan CCC, WBSEDCL and Raghunath Saren, Office Executive, Bundwan CCC, WBSEDCL visited the premises of Budhu Hembram, S/O – Bistu Hembram, Vill –Bhurudanga, PO - Dhadka, PS – Bundwan, Dist – Purulia and inspect his premises. During inspection it was found that he was using electricity dishonestly by bypassing the meter and connecting the incoming power with outgoing wire before entering meter.

From the above arrangement he was using the following electrical equipment's:

- 1) Pump – 1 Nos,
- 2) FAN – 1 Nos,
- 2) Bulb – 4 Nos,

Out of which I seized the following:

- 1) PVC Black colour service cable of approx. 10 ft.

Seizure list was prepared at the site and accused person has been signed.

The inspection team left the premises at 17:35Hrs on 04/04/2024.

The accused person has committed an offence U/S 135/1/b of The Electricity Act – 2003 & subsequently Electricity (Amendment) Act – 2007.

You are requested to take cognizance of this complaint and treat it as F.I.R. and action may be taken as per rule.
