Respected Sir,

In producing herewith one arrested accused person namely Subal Tudu (51y), S/O- Lt. Karamchand Tudu @ Karmu of vill+ PO-Chirudih, PS- Bandwan, Dist- Purulia with the seized articles i.e. 1) Approx. 05 (five) litres illicit distil liquor (CHOLAI MOD) in 01 (One) Jerican bottle marked as Exhibit "A" from which 01 (One) Litre has been taken out in 01 (One) separate bottle from mother quantity as sample marked as Exhibit "B". I beg to submit that on 12/04/2024 at about 19:15 hrs I received a credible source information while I was engaged in Evening Mobile duty vide Bandwan PS C.C No.- 1268/24 Date- 12/04/2024 that one person namely Subal Tudu, S/O- Lt. Karamchand Tudu @ Karmu of vill+ PO-Chirudih, PS- Bandwan, Dist- Purulia is selling Illicit Distil liquor (CHOLAI MOD) without any valid license in front of his house at Chirudih village under Bandwan PS. Accordingly, I informed the said information to O/C, Bandwan P.S and as per his direction, myself along with C/358 Ganesh Ch. Roy and C/3415 Pradip Mondal all are of Bandwan P.S, Dist-Purulia left for Chirudih village to work out the said source information and found that the said person is selling I.D liquor (CHOLAI MOD) to others in front of his dwelling house at vill+ PO-Chirudih, PS- Bandwan, Dist- Purulia. Seeing the Police party, all customers fled way but we managed to apprehend the accused person and on interrogation he disclosed his identity as Subal Tudu, S/O- Lt. Karamchand Tudu @ Karmu of vill+ PO-Chirudih, PS- Bandwan, Dist- Purulia On being asked, he failed to produce any valid documents/ License in respect of selling Illicit Distil liquor (CHOLAI MOD). Accordingly, I seized and labelled all the Illicit Distilled liquor (details in attached seizure list) i.e 1) Approx. 05 (five) litres illicit distil liquor (CHOLAI MOD) in 01 (One) Jerican bottle marked as Exhibit "A" from which 01 (One) Litre has been taken out in 01 (One) separate bottle from mother quantity as sample marked as Exhibit "B" as produced by the said accused Subal Tudu from 19:35 hrs to 19:55 hrs. and prepared proper seizure list duly signed by the seizure witnesses. Then, I arrested him at 20:05 hrs. after maintaining all legal procedures regarding arrest as per Cr.P.C, NHRC guide lines and as laid down by Hon'ble Supreme Court as he committed offence U/S- 46A (c) Bengal Excise Act. 1909. I would like to note down here that after local enquiry the arrest was made because a cognizable offence was being committed in presence of a Police Officer.

Under the above circumstances and fact, I therefore pray that a specific case may kindly be started U/S 46A(C) Bengal Excise Act. 1909 against the arrested accused person namely Subal Tudu (51y), S/O- Lt. Karamchand Tudu @ Karmu of vill+ PO-Chirudih, PS- Bandwan, Dist- Purulia and arrange for it's investigation.
