Dear Sir,

I do hereby lodge complaint empowered by enabling The Indian Electricity Act – 2003, subsequently Electricity (Amendment) Act 2007 to the effect that Ananda Mahato, S/O – Sagar Mahato, Vill – Kanatagora (Mahatopara), PO - Dhadka, PS – Bundwan, Dist – Purulia has committed theft of electricity U/S 135/1/a of The Electricity Act.

On 23/04/2024 about 13:15 Hrs, I, Prashanta Mandal, AE&SM, Bundwan CCC, WBSEDCL, along with Raghunath Saren, Office Executive, Bundwan CCC, WBSEDCL and Majam Ali Asari, HG TSH, Bundwan CCC, WBSEDCL visited the premises of Ananda Mahato, S/O – Sagar Mahato, Vill – Kanatagora (Mahatopara), PO - Dhadka, PS – Bundwan, Dist – Purulia and inspect his premises. During inspection it was found that he was using electricity dishonestly by means of Direct Hooking from the nearest LTOH line.

From the above arrangement he was using the following electrical equipment's:

- 1) Bulb – 2 Nos, 2) FAN – 1 Nos, 3) Grinder Machine – 1 Nos,

Out of which I seized the following:

- 1) A portion of flexible wire red and blue colour (approx. 7 mtr.) with hooking device.
- Seizure list was prepared at the site and accused person has been signed.

The inspection team left the premises at 13:50 Hrs on 23/04/2024.

The accused person has committed an offence U/S 135/1/a of The Electricity Act – 2003 & subsequently Electricity (Amendment) Act – 2007.

You are requested to take cognizance of this complaint and treat it as F.I.R. and action may be taken as per rule.
