Sub: Prayer for lodging FIR.

Sir,

In producing herewith the arrested alleged driver namely Mantulal Mahato (30 Yrs) S/o Athika Mahato of Vill- Sonadungri, P.O- Raigara, PS-Brabazar, Dist- Purulia and seized Pick Up Van having registration No- WB55A/2696 loaded with approx 04 (Four) M.T raw coal and also taken sample of 700 gm approx. raw coal from the Pick Up Van.

I beg to state that on 07.04.2024 at about 15.35 hrs while I, ASI Jaydip Mukherjee along with C/- 1527 Santosh Bauri, C/- 1532 Meghnath Kar all of Barabazar PS, vide Barabazar PS C.C No- 1237/2024, Dtd. 07.04.2024 and GDE No- 422 Dtd. 07.04.2024 were performing mobile duty at PS area, I received information from my source that one Pick Up Van having registration No- WB55A/2696 loaded with illegal raw coal is going towards Bamundiha to Bhagabandh through village road. After receiving the information, I contacted you and as per guidance and instruction we left that place to track and stopped this illegal transportation of coal. After a long chase I managed to stop the vehicle at Bamundiha Hattola more under Barabazar PS at about 15.55 hrs. On seeing the Police party the driver of the said vehicle tried to flee away but we managed to apprehend him. On being asked the apprehended person disclosed his identity noted above. On demand he failed to produce any valid document in respect of loaded raw coal. On preliminary enquiry it could be learnt that the driver along with the owner of the said vehicle were procuring the said illegal coal from different places and transporting the same in a clandestine manner to another district. So, it is reasonable to believe that they were transporting the coal illegally after procuring.

Accordingly, I seized the above noted vehicle loaded with raw coal approx 04 (Four) M.T under proper seizure list duly signed by the accompanied Police persons as there was no availability of any local person, as such I could not collect the signature of the local people in seizure list during seizure. I have taken 700 gm approx. raw coal from the Pick Up Van as sample after preparing proper level. The seizure was made between 16.05 to 16.25 hrs. I also arrested the above noted accused driver at 16.30 hrs after maintaining all formalities regarding arrest. Informed him the ground of arrest and issued Memo of Arrest, Check List. After that we made a proper arrangement and brought the arrested accused and seized vehicle loaded with raw coal at PS for custody.

Therefore, I pray before you that a specific case may kindly be registered against the driver namely Mantulal Mahato (30 Yrs) S/o- Athika Mahato of Vill- Sonadungri, P.O- Raigara, PS-Brabazar, Dist- Purulia and the owner of the seized vehicle Pick Up Van having registration No- WB55A/2696 under proper section of law and arranged its investigation.
