Respected Sir,

With due respect and humble submission, I ASI Krittibas Mahato of Hura PS submitted a suo-moto complaint against the offending driver of the vehicle (Truck) bearing Reg. No. WB-59B/8596 to the effect that during my night mobile duty on 04&05/04/2024 received a telephonic information that one Truck dashed a Culvert at Porashiya Morh on Bankura-Purulia main road (NH-60A). Receiving this information, I informed this matter to O/C Hura PS and as per his direction myself along with force left to Porashiya Morh to work out the said telephonic information. After reaching to the spot i.e. Porashiya Morh found that one Truck bearing Reg. No. WB-59B/8596 loaded with Manganese which was coming from Bankura side and going towards Purulia side dashed a culvert at Porashiya Morh & damaged it, I searched the vehicle and surrounding area but the driver of the said Truck not available there. During primary enquiry it is found that the driver of the said offending vehicle driving the vehicle very rash & negligent and dashed the culvert and fled away. Then I seized the offending vehicle (Truck) bearing Reg. No. WB-59B/8596 loaded with Manganese after preparing proper seizure list duty sign by the witnesses.

Under the above circumstances I pray that a specific case may kindly be started against the involved accused driver of the offending Truck bearing Reg. No. WB-59B/8596 under proper section of law and arrange for its investigation.
