On 27.03.2024 the accused person namely Manoranjan @ Mana Bouri S/O-Lt. Shibu Bauri of Vill-Jambad, PS-Hura, Dist-Purulia could be arrested on the basis of W/A in C/W Hura PS Case No. 16/2012, Dtd-10.03.2024, U/S-399/402 IPC & 3/4 E.S Act. and forwarded before Ld. Court with a prayer for starting a specific case U/S-174A IPC against accused Manoranjan @ Mana Bouri S/O-Lt. Shibu Bauri of Vill-Jambad, PS-Hura, Dist-Purulia.
