Sir,

In producing herewith 02 (Two) arrested accused persons namely (i) Dhiren Ch. Mahato (42) S/O Sristidhar Mahato of Vill- Ekurhatu, PS-Kotshila, Dist-Purulia & (ii) Bikash Lohar (29) S/O Katu Lohar of Jhalda Dera, Ward No-05, PS-Jhalda, Dist-Purulia under arrest along with seized articles as per seizer list i.e. (i) 30 (Thirty) Ltrs. ID Liquor (Cholai) in a three white Plastic Jarican 10 ltr. In each Jarican & (ii) 40 pieces of plastic glass under proper seizure with label.

I ASI Subhas Ch. Mahato of Jhalda PS hereby lodged a written complaint against the above noted accused person to the effect that today (31/03/2024) myself along with (i) C/1221-Yudhistir Kumar (ii) C/231-Mansaram Kumar, (iii) NVF/933 Abani Kumar all of Jhalda PS were performing night mobile duty (This refers to Jhalda PS CC No. 1376/24 dated 31/03/2024 and GDE No. 1716 dated 31/03/2024. During night mobile duty at about 23:05 hrs I received a credible source information that 02 (two) persons were gathered for selling ID Liquor at Jhalda Hatbagan math near Birshamore under Jhalda PS. On receipt such information I immediately informed the matter to you and as per your kind direction I along with force proceeded to work out the information. We reached at Jhalda Hatbagan math near Birshamore at about 23:25 hours and held raid and found that the 02 (two) accused persons namely (i) Dhiren Ch. Mahato (42) S/O Sristidhar Mahato of Vill- Ekurhatu, PS-Jhalda, Dist-Purulia & (ii) Bikash Lohar (29) S/O Katu Lohar of Jhalda Dera, Ward No-05, PS-Jhalda, Dist-Purulia selling ID Liquor at in lieu of money Jhalda Hatbagan math near Birshamore. Seeing the Police party the buyers are fled away. On searched 30 (Thirty) Ltrs. ID Liquor (Cholai) in a three white Plastic Jarican 10 ltr. In each Jarican were found there. On demand they failed to produce any license / authority of the said liquors. On interrogation they also made incoherent statement regarding possession of said liquors and told that they are usually selling the same to the villagers illegally. So, finding no any other alternative I seized in between 23:35 to 23:50 hrs the above noted articles from the possession of the accused persons and labelled, duly singed by the accused persons & witnesses in which 300 ML of ID Liquor (Cholai) in a bottle from mother sample was kept as sample with label. During interrogation they confessed their guilt as such I arrested them after observing all the formalities as per law issuing memo of arrest as the accused person are liable for prosecution U/S-46A (c) of the Bengal Excise Act 1909.

I therefore pray that a specific Case may kindly be started against the accused persons namely (i) Dhiren Ch. Mahato (42) S/O Sristidhar Mahato of Vill- Ekurhatu, PS-Kotshila, Dist-Purulia & (ii) Bikash Lohar (29) S/O Katu Lohar of Jhalda Dera, Ward No-05, PS-Jhalda, Dist-Purulia U/S- 46 A (c) of the Bengal Excise Act 1909.
