Sir,

In producing herewith 02 (Two) arrested accused persons namely (i) Amit Chandra (31) S/O Jiten Chandra of Poddarpara, Ward No-09, PS-Jhalda, Dist-Purulia & (ii) Tapash Chandra (62) S/O Lt. Sevadas Chandra of Poddarpara, Ward No-09, PS-Jhalda, Dist-Purulia under arrest along with seized articles as per seizer list i.e. (i) 18 (Eighteen) Bottles of Country Sprit (Dilkhush) containing 375 ml. each (ii) 07 (Seven) Bottles of Kingfisher containing 600 ml. each under proper seizure with label.

I SI- Dinabandhu Roy of Jhalda PS hereby lodged a written complaint against the above noted accused person to the effect that on the night of (18/19/04/2024) myself along with (i) C/1221-Yudhistir Kumar (ii) C/231-Mansaram Kumar, (iii) C/2111- Mahitosh Mahato (iv) NVF/843- Bibekananda Mahato all of Jhalda PS were performing night mobile duty (This refers to Jhalda PS CC No. 1623/24 dated 18/04/2024 and GDE No. 846 dated 18/04/2024. During night mobile duty at about 05:05 hrs I received a credible source information that 02 (two) persons where going to Poddarpara side from Chatatar under Jhalda PS with Country Sprit. On receipt such information I immediately informed the matter to you and as per your kind direction I along with force proceeded to work out the information. When we reached at Podda para near the house of Amit Chandra and found 02 persons caring 02 hand bag loaded with some articles in a suspicious manner. So I interecepted them, On searched (i) 18 (Eighteen) Bottles of Dilkhush containing 375 ml. each (ii) 07 (Seven) Bottles of Kingfisher containing 600 ml. each were found in those bags. On demand they failed to produce any license / authority of the said liquors. On interrogation they also made incoherent statement regarding possession of said country sprit as well as Kingfisher and told that they are usually selling the same to the local persons illegally. On interrogation they also made incoherent statement regarding possession of said liquors and told that they are usually selling the same to the villagers illegally. On being asked they disclosed their name and address (i) Amit Chandra (31) S/O Jiten Chandra of Poddarpara, Ward No-09, PS-Jhalda, Dist-Purulia & (ii) Tapash Chandra (62) S/O Lt. Sevadas Chandra of Poddarpara, Ward No-09, PS-Jhalda, Dist-Purulia. So, finding no any other alternative I seized the same in between 05:25 to 05:45 hrs the above noted articles from the possession of the accused persons and labelled, duly singed by the accused persons & witnesses in which one bottle of Country sprit (Dilkhush) containing 375 ML and 01 bottle of Kingfisher containing 600 ML, collected as sample from the above noted seized articles with label. During interrogation they confessed their guilt as such I arrested them after observing all the formalities as per law issuing memo of arrest as the accused person are liable for prosecution U/S-46A (c) of the Bengal Excise Act 1909.

I therefore pray that a specific Case may kindly be started against the accused persons namely (i) Amit Chandra (31) S/O Jiten Chandra of Poddarpara, Ward No-09, PS-Jhalda, Dist-Purulia & (ii) Tapash Chandra (62) S/O Lt. Sevadas Chandra of Poddarpara, Ward No-09, PS-Jhalda, Dist-Purulia U/S- 46 A (c) of the Bengal Excise Act 1909.
