I do hereby lodge complaint empowered by enabling the electricity act 2003 subsequently the amendment act 2007 to the effect that Paresh Gorain, S/O- Bharat Gorain of Vill- Mukundapur, P.S- Joypur , Dist- Purulia has used his existing electric connection for the purpose other than the purpose for which the service connection was actually provided which comes U/S 135 1(e) of electricity act 2003 subsequently amendment act 2007.

On 03.04.2024 at about 12:35 P.M. I, Sri Rabindranath Das S/O- Sri Murari Mohan Das, AE & Station Manager, Joypur CCC along with Sri Raushan Kumar, JE(E) Gr-II, S/O- Late Uma Shankar Lal, Joypur CCC, Sri Ganesh Mahato S/O- Late Jagannath Mahato GR1 TSH Joypur CCC and Sri Shibaram Mahato S/O- Late Sristidhar Mahato, GR1 TSH Joypur CCC entered the premises of Paresh Gorain, S/O- Bharat Gorain of Vill- Mukundapur P.S- Joypur , Dist- Purulia and found that Paresh Gorain supplied electricity unauthorizedly from his existing meter (No. H802078, Con ID: 242115802) which is Domestic connection and used as Commercial nature to a Customer Service Point of State Bank of India of Gorbh Joypur Branch (CSP Code: 3B680744) with CSP Name- Ashutosh Gorain. The connection could not be disconnected due to obstruction aroused by Ashutosh Gorain S/O- Paresh Gorain and Bharat Gorain (father of Paresh Gorain). Final Reading of meter was 7315 kWh. The inspection team left the premises at 01.10 P.M.

Paresh Gorain, S/O- Bharat Gorain of Vill- Mukundapur, P.S- Joypur , Dist- Purulia has committed an offence U/S 135 1(e) Electricity Act, 2003(Amendment Act, 2007), so you are requested to take cognizance of this complaint and treat it as F.I.R.
