Sir,

In producing herewith, the arrested accused person namely Habib Ansary (42 years) S/O- Lt. Mayunuddin Ansary of Vill- Karkara, PS - Joypur, Dist.- Purulia and seized 03 (Three) Nos. two wheelers loaded with total 09 Qnths. (approx) steam coal. Fact of the case in brief is that on 03.04.2024 I SI Malay Mishra along with C/1177 Samir Das, C/1358 Sanjib Kr Patra and C/2687 Ramantaj Mahanty were performing day mobile duty in Joypur PS area vide Joypur PS CC No. 1568/24. On 03/04/2024 at about 13.23 hrs. received a credible source information that some persons loaded with coal in their two wheelers coming from Jharkhand side toward Chas More with a view to illegal transporting. After receiving such information, I informed the matter to IC Joypur PS and as per his kind direction we rushed to work out the information. When we reached near at Bartard more under PS Joypur found that some persons having loaded coal in two wheelers were coming from Jharkhand side, at that time we were able to apprehend 03 (Three) Nos. of two wheelers i.e. (1) One grey colour Vespa Motorcycle without Registration number loaded with approx 03 (three) Qnths. Coal in plastic bag, (2) One light blue colour Vespa Motorcycle without Registration number loaded with approx 03 (three) Qnths. Coal in plastic bag, (3) One grey colour Vespa Motorcycle without Registration number loaded with approx 03 (three) Qnths coal in plastic bag and one rider as noted above but other two riders fled away from the spot left behind their motor cycle loaded with coal. On asking the rider of the said two-wheeler failed to produce any papers in respect of said loaded Coal as well as papers in respect of two wheelers. He also made incoherent statements in respect of possession of the said coal. So, it is reasonable to believe that the rider of those two wheelers collected the said steam coal either by theft or by any fraudulent means from anywhere and transporting the same to run clandestine business for wrongful gains with the help of others. On interrogation the above noted person confessed his guilt and also disclosed the name of other two co-accused persons who fled away from the PO left behind the Vespa motorcycle loaded with coal, namely (1) Mantaj Ansary, S/O- Ansary of Vill- Karkara, PS - Joypur, Dist - Purulia (2) Manoj Gorai, S/O- Naran Gorai of Karkara, Dih para under PS- Joypur, Dist.- Purulia. As such it is every reason to believe that those persons along with two wheelers are transporting the said steam coal illegally. I seized above 03 (three) nos. two wheelers loaded with Coal and approx 09 Qnths. steam coal under proper seizure list duly signed by the accused person and witnesses. I also arrested accused Habib Ansary (42 years) S/O- Lt. Mayunuddin Ansary of Vill- Karkara, PS - Joypur, Dist - Purulia after observing all formalities and narrating his ground of arrest. No public witnesses were turned up there. Approx 01 (One) K.G. of Steam Coal in each two wheelers collected as sample coal.

I therefore pray before you, kindly lodge an FIR against the accused person namely (1) Habib Ansary (42 years) S/O- Lt. Mayunuddin Ansary of Vill- Karkara, PS - Joypur, Dist.- Purulia, (2) Mantaj Ansary, S/O- Ansary of Vill- Karkara, PS - Joypur, Dist - Purulia (3) Manoj Gorai, S/O- Naran Gorai of Karkara, Dih para under PS- Joypur, Dist.- Purulia as per law and arrange for its investigation.
