I S.I. Asoke Kr. Sen of Manbazar PS do here by lodge a suo moto complaint against the following villagers namely (1) Sk Akhtar S/o not noted (2) Sk Aslam @ Tigar S/o Sk Akhtar, (3) Sk Akram S/o Sk Sadhu, (4) Sk. Garjahan @ Chamta S/o Sk Siddik, (5) Mir Pappu S/o Sk Kader, (6) Sk Samim S/o Not noted, (7) Sk Bappan S/o Kuddus, (8) Sk Kaltu S/o Not noted, (9) Sk Rahul S/o Sk Sadhu, (10) Sk. Abu Kalam @ Sk. Laltu S/O Lt- Sk. Jalaluddin, (11) Mir Ajahar Ali @ Mir Babban S/O Mir Abdul Kuddus, (12) Sk Musaddik @ Bhagina S/O Lt- Sk Julfukar, (13) Mir Rahamattulla @ Bappa S/O Mir Abdul Kuddus (14) Mustak Ali S/O Lt- Hamid Ali all are village Patharkata, PS- Manbazar, Dist- Purulia and 50/60 others of Patharkata village under Manbazar PS to the effect that, on 07.04.2024 at about 09:35 hrs. while ASI Animesh Mukherjee was engaged for day mobile duty with C/786 Suchand Mandi and NVE/697 Debendra Nath Bauri vide Manbazar PS C.C. No- 864 dtd- 07.04.2024 and GDE No- 273 Dtd- 07.04.2024 received a telephonic information that a hot altercation and scuffling is going on between a women and some other public near Samsan kali Mandir, Indkuri and as per direction ASI Animesh Mukherjee along with force left for work out the information.

At about 09:55 hrs, while ASI Animesh Mukherjee & force reached at the P.O. found that an hostile mob under the leadership of (1) Sk Akhtar S/o not noted (2) Sk Aslam @ Tigar S/o Sk Akhtar, (3) Sk Akram S/o Sk Sadhu, (4) Sk. Garjahan @ Chamta S/o Sk Siddik, (5) Mir Pappu S/o Sk Kader, (6) Sk Samim S/o Not noted, (7) Sk Bappan S/o Kuddus, (8) Sk Kaltu S/o Not noted, (9) Sk Rahul S/o Sk Sadhu, (10) Sk. Abu Kalam @ Sk. Laltu S/O Lt- Sk. Jalaluddin, (11) Mir Ajahar Ali @ Mir Babban S/O Mir Abdul Kuddus, (12) Sk Musaddik @ Bhagina S/O Lt- Sk Julfukar, (13) Mir Rahamattulla @ Bappa S/O Mir Abdul Kuddus (14) Mustak Ali S/O Lt- Hamid Ali all are village Patharkata, PS- Manbazar, Dist- Purulia surrounded a woman who was lynched by that mob causing injury on her person. ASI Animesh Mukherjee tried to rescue the women from the grip of the mob but they restrained us and deterred the police party from discharging our bona fide Govt Duty. Police party tried to make them understand the legal aspects but the agitated mob did not pay any heed to their appeal. Then ASI Animesh Mukherjee informed the matter to PS and after sometimes, being reinforced by me, S.I. Uttam Kr. Mandal, C/824 Mahananda Routh, VP Milan Chatterjee reached the PO. Seeing the reinforcement, the situation got escalated and the mob became more violent. It is to note here that the hostile mob under the leadership of Sk Akhtar and Sk Tigar @ Sk Aslam got strengthened up and they were using small vehicles and motor cycles to carry the mob from Patharkata village to the PO among which one of the vehicle was of "FORD" Company without having any registration number. The hostile mob being armed with lathi, started pelting stone toward the police party and manhandled ASI/ Animesh Mukherjee, C/824 Mahananda Routh and V.P. Milan Chattejee, torn the police uniform of ASI Animesh Mukherjee. The mob was so violent that they assaulted the V.P. Milan Chatterjee brutally by knocking him down on the ground and used their legs on his throat with a view to kill him. The above noted police personals sustained severe injury on their person due to the manhandling of the hostile mob. The hostile mob also started ransacking the police guardrail placed on


the road and also broke the windscreen of the Govt. police vehicle bearing reg. No- WB 24K/ 7673. To get the situation under control, the police party used the minimum force and rescue the lady from the grip of the mob and dispersed the mob.

Hence a specific case may kindly be started against the (1) Sk Akhtar S/o not noted (2) Sk Aslam @ Tigar S/o Sk Akhtar, (3) Sk Akram S/o Sk Sadhu, (4) Sk. Garjahan @ Chamta S/o Sk Siddik, (5) Mir Pappu S/o Sk Kader, (6) Sk Samim S/o Not noted, (7) Sk Bappan S/o Kuddus, (8) Sk Kaltu S/o Not noted, (9) Sk Rahul S/o Sk Sadhu, (10) Sk. Abu Kalam @ Sk. Laltu S/O Lt- Sk. Jalaluddin, (11) Mir Ajahar Ali @ Mir Babban S/O Mir Abdul Kuddus, (12) Sk Musaddik @ Bhagina S/O Lt- Sk Julfukar, (13) Mir Rahamattulla @ Bappa S/O Mir Abdul Kuddus (14) Mustak Ali S/O Lt- Hamid Ali and 50/60 others of Patharkata village how manhandle the police party team and deter the police party from performing the Govt. duty.
