Sir,

In producing here with one accused person namely Aswini Sing Sardar @ Sadhu (53 Yrs) S/O-Lt Manindra Sing Sardar of Vill-Kasidih, PS- Manbazar District Purulia along with seized articles i.e. 17 (Seventeen) pcs. Sealed bottles of country spirit styled as 'DIL KHUSH' each bottle containing 600 ml in which 01 (One) bottle as sample. Total 17 X 600 ML = 10.200 ML which were seized under proper seizure list.

I ASI Animesh Mukherjee of Manbazar PS do here by lodge a written complaint against accused namely Aswini Sing Sardar @ Sadhu (53 Yrs) S/O-Lt Manindra Sing Sardar of Vill-Kasidih, PS- Manbazar District Purulia to the effect that today myself along with C/824 Mahananda Routh and C/794 Ajoy Kr Mahato were performing Evening Mobile duty vide Manbazar Ps GDE No-527 Dated.12.04.2024 & C.C No-909 Date 12.04.2024 at 18.05 hrs received a telephonic information from a reliable source that one Aswini Sing Sardar @ Sadhu (53 Yrs) S/O-Lt Manindra Sing Sardar of Vill-Kasidih, PS- Manbazar District Purulia has stocked country spirit illegally at his dwelling house at Kasidih village, PS-Manbazar, Dist-Purulia and selling the same to hike price for his personal gain. I informed the matter to O/C Manbazar PS over Mobile phone and as per order of O/C Manbazar PS myself along with above noted force rushed to the spot for raid by Govt. vehicle at about 18:35 hrs. myself along with force reached at Kasidih village and held raid in the house of said accused person namely Aswini Sing Sardar @ Sadhu S/O-Lt Manindra Sing Sardar and found that he is selling the country spirit at his dwelling house. Seeing the police party some persons fled away and said Aswini Sing Sardar tried to conceal himself but we were able to apprehend him and also detained him. I asked him to produce valid license or valid papers for selling country spirit, but he failed to produce any valid license or documents for possessing / selling the same. So I seized the above mentioned articles after preparing proper seizure list duly signed by accused person and available witnesses and arrested the above noted accused person and informing his the ground of arrest.

Hence, I pray that, a specific case may kindly be started against arrested accused person namely Aswini Sing Sardar @ Sadhu (53 Yrs) S/O-Lt Manindra Sing Sardar of Vill-Kasidih, PS-Manbazar District Purulia as per law and arrange for its investigation.
