

l. That the complainant Arvind Rai S/O Alarakh Rai, resident of Lalganj, Lalganj Azamgarh, State: Uttar pradesh, presently R/O housing of Bravo Sponge Iron Pvt. Ltd. currently posted as an Assistant General Manager of the said company.

2. That on 02-03-2024 at about 3.04 P.M. and 3.12 P.M. two vehicles being Regn. No: - WE31N-0363 and WE31N-0517 with load -ed Coal, entered into the complainant's company at Bravo Sponge Iron Private Limited for unloading, The two accused drivers and other two accused helpers of the said vehicle accompanying these vehicles were present during the unloading process.



3. That following the unloading, sample of the coal were tested in the complainant's laboratory, revealing that the quality of the coal deviated significantly from the agreed specifications. The coal, purpotedly transported from the Haldia Post, did not match the schedule quality standards.

4. That immediately the complainant informed to acced. person Transporters of M/S Pratik and Apex Road lind and also to the acced. person owner of the said vehicles, about their cheating discrepencies. The said acced. persons acknowledged the malpractice and requested to hold the said loaded vehicles until the matter was resolved. All the acced. persons intentionally acted their such fradulent activities regular ly.

5. That the acced. persons i.e. Transporter and the Owner of the vehicles were informed regarding replaced the original coal with interior quality during transit.

6. That on 07-03-2024 the one acced. person Mr. Pishi Jaiswal owner of the vehicles confessed their involvement of his drivers and helpers in such cheating and fradulent, after all the acced. person assured the complainant for losses incurred by complainant's company.

7. That thereafter the complainant has told to the acced.
persons to resolve their such disputes several times. But
they did not pay any heed still.

8. That all the Accused persons cheated and thereay dishonest ly induced the company of the complainant to alter such coal with their conspiracy.
