


Most Respectfully Sheweth:-

- 1. That, Complainant happens to be a local resident of Vill- Chakra, P.O- Chakra, P.S-Purulia(M) Dist- Purulia(W.B).
- 2. That the complainant has a Savings bank account at Punjab National Bank, Purulia Branch, Purulia having account number 0475000100171152 having a balance of around Rs. 1,30,000/-(Rupees One lakh thirty thousand only) .

3. That in the above stated account an amount of Rs.50,000/- on 04.01.2024 and amount of Rs.50,000/- on 05.01.2024 total Rs.1,00,000/-(Rupees one lakh) was withdrawn by the accused person by doing forged signatures of the complainant.

POLICE OF MINION OF THE POLICE OF THE POLICE

That when the complaint went to withdraw some amount of money from her bank account on 05.01.2024 the Branch Manager said her that she withdrew money few minutes ago, listening to it the complainant informed that she did not come to withdraw any money, then the manager enquired the matter and saw the C.C T.V footage where in it was found that it was the accused person who withdrew the money from the bank.

- 5. That it is pertinent to mention that the accused person very often visited the house of the complainant and used to stay there, the complainant got some money from the Government for acquisition of land while construction of N.H-32, as she was a land loser, she got compensation of Rs.3,50,000/- which was kept at her house and few old bank passbooks.
- That the accused person on 02.08.2023 came to the house of the complainant and stole the cash of Rs.3,50,000/- and the bank passbook of the complainant. The complaint is of such firm belief as the accused person forged the signatures of her and withdrew the amount of Rs.50,000/- on 04.01.2024 and Rs.50,000/- on 05.01.2024 in totality Rs.1,00,000/-.
- 7. That when the complainant came to know about the fact she approached the accused person to return her money, the accused person along with her husband and two sons assaulted the complainant used slang languages against her. The complainant somehow saved her life and returned her home.
- 8. That the complainant submitted a written complaint before the Purulia (M) P.S, but the P.S denied to take the complaint. Later the matter has been informed to the I.C Purulia (M) P.S, Purulia in writing, through registered post on 19.02.2024 which was delivered to the Police Station on 20.2.2024 and the P.S is well posted with the matter, but for reasons unknown no legal action or F.I.R has been lodged against the accused persons.
- 9. That later getting no other alternative the matter has been informed in writing to the Superintendent of Police, Purulia on 26.02.2024 but till date no legal initiatives has been taken by the Office concerned hence the complainant had no other alternative but to approach before the Ld. Court of Law to file this petition praying for taking necessary action against the accused person who has committed illegalities against her.
- 10. That, proper Police investigation should be taken up by treating this complaint as F.I.R and action should be taken against the accused persons as per Law for the Interest of Justice.



- 11. That, as I.C Purulia (M) Police Station, Purulia in spite of getting specific information/ complaint from the complaint has not instituted any F.I.R against the accused person nor any initiative has been taken from the Office of the Superintendent of Police, Purulia, let this complaint be forwarded to I.C Purulia (M) Police Station, Purulia for treating the same as F.I.R and for undertaking investigation.
- 12. That as required all the formalities of Lodging Complain U/S- 154 Cr.P.C, U/S- 154(3) Cr.P.Code has duly been complied with by the complainant. But yet no F.I.R has been lodged against the accused persons.
- 13. That the Photostat copies of the application send to the I.C Purulia (M) P.S, Purulia, its postal receipt, track report, application submitted before the Superintendent of Police, Purulia are attached herewith this petition with a separate firisti.

Hence it is prayed that Your Honour may graciously be pleased to pass appropriate Orders U/S- 156(3) Cr.P.C by directing the I.C Purulia(M) P.S, Purulia to treat the complaint as F.I.R and undertake proper investigation.
