An application under section 156 (3) Cr. P.C praying for a direction upon O.C, Purulia (M) P.S for causing investigation into the matter.

The complainant named above most respectfully beg to state as follows:-

That the complainant Hemala Mahato, W/O-Lt.-Shankar Mahato is a permanent resident of Vill:- Hatowara, P.O-Gengara, P.S-Purulia (M), Dist:-Purulia.

That on 18.03.2024 at around 5-00 a.m the complainant woke up from her sleep as usual and found that three cows and three goats (Khasi) missing from her shed and thereafter the complainant started to search her missing cattles and there and there in the locality but did not trace out.

That thereafter the complainant again started to search her missing cattles and goats and after long search the complainant came to learn that said cows and goats were in the house of Ajit Mahato, S/O Angad Mahato of Village Chamrubera under Purulia (M) P.S, District-Purulia.

That later the complainant got information and could understand that her neighbour Anita Mahato, W/O Jiru Mahato hatched up a criminal conspiracy with Patit Mahato, S/O Mansaram Mahato, Ramdulal Mahato, S/O Mansaram Mahato, Achinta Mahato, S/O Patit Mahato and Raghunath Mahato, S/O Lambodar Mahato in league with each other all the accused persons committed theft of those cattle and goats of the complainant for their wrongful gain' causing wrongful loss to the complainant on the date of incident at night.

That the complainant also came to learn that on the date of incident on 18.03.2024 at night her neighbour Anita Mahato along with other miscreants entered into the house of the complainant by breaking open the door of the complainant and took away three goats and three cows from her cow-shed and confined those cows and goats in the house of Ajit Mahato at village Chamrubera under Purulia (M) P.S, District-Purulia.

That on getting information of such illegal and high handed activities the complainants started to gather information and during query the complainant came to know that all the aforesaid accused persons entered into criminal conspiracy with each other for their wrongful gain and for causing wrongful loss to the complainant.

That after gathering courage the complainant went to Purulia (M P.S and ventilated her grievance but no action has been taken.



That the entire incident took place in the dead of night and for which someone could see the accused to enter into the house of the complainant.

That thereafter the matter has been reported to the Superintendent of Police, Purulia on 22.03.2024 but till date no case has been started regarding the aforesaid incident as the miscreant has political influence.

That the accused persons has committed the offence under sections 451/379/399/201/120B/34 of IPC.

That a through investigation is required by a specialized agency for recovery of those stolen cattle and goats and also for unearthing the truth otherwise truth would not see the light of the day.

Under the aforesaid circumstances, It is prayed that your honour may be pleased to send the petition of complaint to O.C, Purulia (M) Police Station under section 156 (3) Cr.P.C with a direction to cause investigation into the matter after treating the petition of complaint as FIR and do justice thereby.
