Sub: FIR against Mr Kartik Mahaldar and others for causing by commission and omission death of my father Mr S.K Hafiz Hussain in Deben Mahato Hospital, Purulia on 12.04.2024.

Sir,

This is to inform you that my father Sk Hafiz Hussain male aged 68 received a head injury after falling near our residence, he was bleeding profusely and was unable to breathe. We rushed him to Deben Mahato hospital emergency ward around 8 pm dt 12.04.2024.

Neither of two on duty doctors i.e Suchitra Murmu & Debalina Kar as per roster were present there. Patient was attended in a casual manner by a person who did not disclose his identity neither he stamped his name and regn number in the ticket while attending my father. I suspect even if he is a doctor.

He casually without taking cognizance of seriousness of matter and need of immediate surgical attention referred the patient to admit in Medical ward and delayed the matter casually leading to loss of crucial golden period of 20-30 minutes . The admission ticket counter people were also delaying the matter .

The patient was further not attended by referred doctor (name in the Ticket) of medical ward and we were rushing from pillar to post for help .We somehow ran to surgical ward for help wherein one doctor upon our plea and request attended him.

There was non availabilities of medicines and stocks also the nurses were non responsive and were not giving any due importance, the doctor attended him casually after some time declared him dead around 9:30-9:45 PM.

These two are complete opposing course of actions by doctors of same hospital in which one was not on duty also while other was in surgical ward, whereas the doctor referred to medical ward has not been seen neither he attended.

What is pertinent to mention is non availability of on duty doctors and failure or MSPV and CMOH to maintain order which is so crucial to a person's life and death, and willfull delay & wrongful referencing of patient to medical ward by an unauthorized person i.e Mr Kartik Mahaldar, sitting in emergency ward, who denied signing or stamping or disclosing name in a criminal fashion, completely overlooking the urgency of matter whereas at the same time another doctor of surgical ward upon seeing the urgent condition attended him albeit poorly.

Mr Kartik Mahaldar has fled the hospital then and there and is absconding, the ward master is not ready to cooperate, MSVP is not available in hospital other few officers of Deben Mahato hospital are

discussing about tampering of evidence, emergency tickets etc. We have recorded videos and taken pictures of culprits.

The doctor attending and wrongully referring and killing crucial golden period is Mr Kartik Mahaldar and his opposing wrongful and casual decision to refer to medical male ward and all above has led to death of my beloved father . This all has happened between 8 pm to 10:30pm .

Hence it is requested that.

- 1. Mr Kartik mahaldar may be arrested under sec IPC 304A, 337 or relevant sections as needful to to ensure justice is delivered for his wrongful commission / omission as above and it may be please ensured that he does not flea from city / country.
- 2. Relevant sections for commission and omission may be pressed upon two missing doctors Suchitra Murmu & Debalina Kar who did not attend the patient and he was left to die in the above manner.
- 3. Relevant sections and necessary actions for commission and omission may be taken against MSVP / CMOH who failed to ensure order and willfully ignore open defiance of duty rosters.
- 4. It may also be directed to hospital that there should not be any tampering of evidence.
- 5. CCTV footage of the hospital may be secured immediately.
- 6. I have requsted MSVP / hospital for forensic post mortem with videography , it may also be ensured please.
- 7. This matter may be sent for judicial enquiry of death by Judicial Magistrate Class- 1 please. There are witnesses the whole situation and we request for complete justice without any partisanism.

This may be lodged as an FIR immediately.
