Respected Sir,

In producing herewith one seized Tractor having Registration No. WB55B/2325, Engine No-RKD2EAN1736 Chassis NO-MBNABAEXPKRD07426 with a sand loaded trolley approximately 100 Cft sand and with seizure list.

I beg to report that on 21.04.2024 at 21:45 hrs I along with force (1) C11 Kajal Mukherjee (2) C/178 Tulsi Mahato both of Purulia (T) PS left PS to perform RT mobile duty vide Purulia vide Purulia (T) PS CC No 852/2024 and GDE No 1451 Dt. 21.04.2024 at PS area. While performing the RT Mobile duty, I received an information at 04:15 hrs that a suspicious tractor loaded with sand was coming from Tamna PS area side on the way Bhagabandh Para towards Purulia Town. Subsequently, I along with force proceeded towards Bhagabandh Para to work out the information. While on 22.04.24 at 04:45 hrs I along with force arrived near at Bhagabandh Para under Purulia (T) PS and found that 01 (one) tractor was coming from Bhagabandh Para in front of Ram Shyam Lodge on Bhagabandh para road. Seeing the police van from a distance the driver of the tractor immediately stopped the vehicle and ran away from the place left the vehicle (Tractor) bearing No. WB55B/2325 attached with sand loaded trolley without any number plate on the road. I chased him but unfortunately unable to catch him. Driver ran away which was quite suspicious and therefore it is reasonable to believe that the driver of the tractor loaded the said sand in clandestine with the owner of the vehicle by illegal means for selling the same to make profit by dishonestly and they have been running a clandestine business. So it is reasoned to belief that he in clandestine with the owner of the vehicle procured the said sand form Tamna PS side by fraudulently means or theft by any means for transporting the same to run clandestine business. So I seized one Mahindra Company Tractor bearing Reg. No WB55B/2325, Engine No-RKD2EAN1736 Chassis NO-MBNABAEXPKRD07426 attached with Trolley loaded with Sand approx 100 Cft without any number plate on the trolley under proper seizure list in between 05:05 hrs to 05:35 hrs. in presence of available witnesses. No any public witness was present at the odd time. Thereafter, I brought the seized tractor to Purulia (T) PS compound and submitted the complaint for starting a specific case against the owner and driver of Tractor bearing Reg. No. WB55B/2325.

Under the above facts and circumstances I beg to pray kindly take lawful action against the owner and the driver of the tractor bearing no WB55B/2325 of the vehicle as they committed offence U/S 379/411/414 of the IPC & 21(1)(4) of Mines and Minerals (R&D) Act. 1957.
